In accordance with Agreed Order DE 19430 (AO), Arcadis U.S., Inc. (Arcadis) has prepared this Progress Report on behalf of Phillips 66 Company (Phillips 66) and City Investors XI L.L.C (City Investors) to document activities conducted for the Block 37 Site (site) in February 2025. The site is generally located at 600 through 630 Westlake Avenue North in Seattle, Washington.

This Progress Report provides a summary of activities performed during the reporting period; deviations from the scope of work; changes in key personnel involved with the work; deviations from the schedule and resolution; a summary of sampling and analytical reports; work planned and deliverables for the next reporting period; and public or regulatory communications.

#### **ACTIVITIES CONDUCTED DURING THE REPORTING PERIOD**

In accordance with the AO, the following work was conducted for the site in February 2025:

- On February 4, 2025, Arcadis provided an updated 2025 Groundwater Monitoring Memorandum to the Washington State Department of Ecology (Ecology) outlining the scope of work for quarterly groundwater monitoring at the site and on February 5, 2025, Ecology acknowledged the receipt.
- On February 13, 2025, Arcadis submitted the monthly Progress Report for January 2025.
- On February 24, 2025, Arcadis provided an update to Ecology via email regarding confirmation of the data gap closure for on-Property borings at the site. Results of the evaluation will be presented in the Agency Draft Review Remedial Investigation Report (ADR RI Report).
