### Cleanup Status Update

In 2014, Ecology allowed remaining contamination to break down naturally (a process called Monitored Natural Attenuation). Our latest review found that:

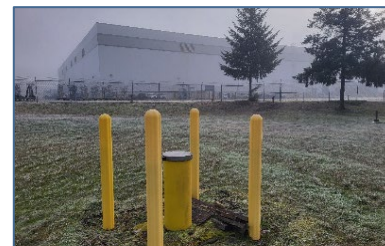
- The cleanup method is **effective in protecting human health and the environment**.
- Groundwater monitoring shows **contamination levels are decreasing**.
- Ecology's cleanup regulations are being followed.

We will conduct the next periodic review in five years.

### Cleanup History

Past cleanup efforts include soil and waste removal, groundwater treatment, and ongoing monitoring. In 2007, private wells were connected to the public water supply. Due to these efforts, there is very little risk of human exposure to the contamination.

The remaining contaminant, carbon tetrachloride (CTC), has been decreasing over time. Ecology continues to watch groundwater quality to ensure cleanup progresses as expected and contaminant levels continue to naturally decrease.
