Per our guidance for the expedited VCP process, quarterly progress reports are due on March 10, 2025.

It would be helpful if you could include at the top of your email in **bold** font if you are waiting for anything from Ecology.

This progress report can be made via email, and should include responses to each of the following from our guidance. We recommend that you simply insert your response below each of the following bullets in your email reply.

- Description and status of Site characterization or cleanup work (completed during past quarter or ongoing work). *As we discussed, TPH and related impacts have been defined; however, the exact source of the PCE in MW-1 is still unknown. While it is presumed to have come from a former dry cleaning facility on the same city block and may have been drawn towards MW-1 from historical remediation pumping, there is not enough data to confirm the point source origin of the release that Ecology can list as a separate site. Ecology suggested evaluating the utility corridor, particularly the sanitary and storm sewer, for soil gas, confirming direction of flow, and any other info that might be helpful. If the data can be tied to a specific property that Ecology can list as a separate site, it will allow for greater flexibility in outlining a path to closure for the Liberty Valero site.*
