Farallon Consulting, L.L.C. has prepared this Second Quarter 2025 Progress Report on behalf of The Estate of Barbara J. Nelson and WCN GST Non-Exempt Marital Trust No. 2 for the Thompson Field Gunshy Manor Site (Thompson Field Site) located in the vicinity of 420 196th Avenue Northeast in Redmond, Washington. The Thompson Field Site is listed with Cleanup Site ID 15285 and was assigned Washington State Department of Ecology (Ecology) Expedited VCP Project ID XN0021.

Description and status of Site characterization or cleanup work (completed during past quarter or ongoing work).

- All existing groundwater monitoring wells on the Site were decommissioned prior to the start of cleanup action excavation activities;
- Cleanup Action excavation activities to remove soil impacted by carcinogenic polycyclic aromatic hydrocarbons (cPAH) and naphthalene at the Site began in May 2025 and is currently ongoing. Approximately 9,200 tons of the estimated 18,000 tons impacted soil has been removed to date.
- Farallon collected performance and confirmation soil samples to refine the lateral and vertical
 extents of the contamination in soil at the Site. The results were used to refine the limits of the
 excavation; the limits do not differ significantly from the ones previously provided to Ecology.
- Farallon collected a sample of water observed at the bottom of the excavation area and submitted it to the laboratory for cPAHs and naphthalene analysis. Results are currently pending.
