In accordance with Agreed Order DE 19430 (AO), Arcadis U.S., Inc. (Arcadis) has prepared this Progress Report on behalf of Phillips 66 Company (Phillips 66) and City Investors XI L.L.C (City Investors) to document activities conducted for the Block 37 Site (site) in June 2025. The site is generally located at 600 through 630 Westlake Avenue North in Seattle, Washington.

This Progress Report provides a summary of activities performed during the reporting period; deviations from the scope of work; changes in key personnel involved with the work; deviations from the schedule and resolution; a summary of sampling and analytical reports; work planned and deliverables for the next reporting period; and public or regulatory communications.

ACTIVITIES CONDUCTED DURING THE REPORTING PERIOD

In accordance with the AO, the following work was conducted for the site in June 2025:

- On June 16, 2025, Arcadis submitted the monthly Progress Report for May 2025.
- On June 18 and 27, 2025, Arcadis received supplemental metals analytical results from the April groundwater monitoring event.

CHANGES IN KEY PERSONNEL

- In June 2025, there were no key personnel changes.

DEVIATIONS FROM APPROVED SCOPE OF WORK

- In June 2025, there were no deviations to the scope of work as defined in the AO, Section VII (Work to Be Performed).

- On June 30, 2025, Arcadis received and responded clarification questions from Ecology on the May Progress Report regarding wells that were not successfully sampled in the first quarter event.

SAMPLING PERFORMED, RESULTS, DATA VALIDATION, AND EIM DATABASE UPLOADS

- Sampling was not performed in June 2025.
- Data validation and the Ecology Environmental Information Management (EIM) database upload is continuing for laboratory analytical results received from groundwater sampling performed during the second quarter 2025 (April 28 through 30, 2025).

WORK PLANNED FOR NEXT REPORTING PERIOD

- Complete EIM upload and data validation for laboratory analytical results received from groundwater sampling performed during the second quarter 2025.
- Conduct third quarter groundwater gauging and sampling event scheduled for July 21st – 23rd in accordance with the Remedial Investigation Work Plan and 2025 Groundwater Monitoring Memorandum.

PUBLIC OR REGULATORY COMMUNICATIONS

- Phillips 66 and City Investors have not participated in any meetings with interested members of the public or local governments, nor had any formal communications with Ecology personnel during this reporting period.
