Anchor QEA prepared this Quarterly Progress Report on behalf of the City of Anacortes (City). This report documents the activities conducted during the months of April through June 2025 in connection with the A Avenue Landfill Site generally located in the vicinity of A Avenue and 37th Street in Anacortes, Washington (Site). Remedial activities are being performed at the Site in accordance with an Agreed Order (AO) issued by the Washington State Department of Ecology (Ecology) on February 7, 2025 (No. DE 22379). Anchor QEA prepared this Quarterly Progress Report in accordance with the requirements in Section VII.C of the AO.

This Quarterly Progress Report provides a summary of the following:

- Activities that have taken place during the previous quarter (i.e., the reporting period; April through June 2025)

- On May 8, 2025, submitted the Draft RIWP and SQAPP to Ecology.

No sampling or test results were received during the reporting period.

There were no deviations from the scope of work or schedule during this reporting period, and none are planned in the upcoming quarter.
