Dear Deborah Taege:

This work is being done under Agreed Order No. 9514 between Washington State Department of Ecology (Ecology) and Olin Corporation and Mallinckrodt US Holdings LLC (the Companies), and in compliance with the Model Toxics Control Act (MTCA), Chapter 70A.305 RCW.

An environmental covenant (EC) for the Site was electronically recorded by Pierce County on August 1st, 2014¹. In May 2025, Ecology was notified that a small portion, near the southernmost boundary line of Pierce County tax parcel 0419312066, was conveyed to the northern portion of Pierce County tax parcel 0419314026. The requirements of the 2014 Environmental Covenant are not required to follow the newly conveyed portion of Pierce County tax parcel 0419312066. It is Ecology's belief that this change does not lessen the protectiveness of the Environmental Covenant or hinder the ongoing monitored natural attenuation at the Site.

The existing EC, however, needs to be replaced with a superseding EC to reflect the current parcel boundaries. Ecology will draft the superseding EC and forward the draft for your review in the coming weeks. The Grantor of the EC, Boeing, will be responsible for filing the EC with the Pierce County Recorder's Office and providing the Department of Ecology with the recorded
