Aspect Consulting (Aspect), has prepared this Progress Report on behalf of potentially liable persons (PLPs) Strickland Real Estate Holdings (SREH) and Chevron Environmental Management Company (CEMC), who are signatories to Washington State Department of Ecology (Ecology) Agreed Order (AO) #14315, effective September 10, 2018, for the Texaco Strickland Site (Site). The AO requires PLPs to submit quarterly progress reports to Ecology until satisfaction of the AO.

This Progress Report No. 27 is for the 2nd quarter 2025 reporting period ending on June 30, 2025.

Progress Made During the Reporting Period

The following sections detail the progress during the reporting period.

- Aspect prepared the draft Feasibility Study and Cleanup Action Plan to support the selection of a final remedy for the Site in accordance with the Model Toxics Control Act and the AO. The draft Feasibility Study and Draft Cleanup Action Plan was submitted to CEMC for review on May 7, 2025 and was submitted to Ecology on May 22, 2025. Ecology provided comments to the draft Feasibility Study and Cleanup Action Plan on June 5, 2025. Aspect began addressing the Ecology comments in June and anticipates the submittal of these documents' Public Review drafts to Ecology in early August.
- Investigation-derived waste (IDW) from the post-interim action groundwater monitoring activities, consisting of a single 55-gallon drum containing purged groundwater was removed from the Site on May 21, 2025.

There was no sampling or testing during this reporting period.
