Ecology received an email from your consultant, Troy Bussey Jr, Pioneer Technologies Corporation, on August 12, 2025, requesting a schedule extension for submitting the Phase I RI data report and Phase 2 RI work plan addendum (data report and work plan) required under Agreed Order No. DE 19403. The data report and work plan were due on August 9, 2025. Because additional time is needed to complete the data report and work plan, the Port requested a schedule extension until September 12, 2025, for the data report and work plan. Ecology grants a 45-day schedule extension. The revised submittal date for the data report and revised work plan is now September 23, 2025.



On behalf of the Port, I am requesting a Sound Mattress schedule extension from August 9 to September 11 for submitting: (1) documentation of Phase 1 investigation activities and results, (2) Phase 1 EIM results, and (3) a Work Plan addendum for Phase 2. Per our previous discussions, you had indicated that submitting these documents within a week or so after August 9 would be acceptable. However, we need a little bit more time because (1) the evaluation and documentation of the MiHPT results has taken longer than originally expected, and (2) we would like to meet with you to discuss a few key findings before we submit the aforementioned documentation (which could occur during our September 4th call or earlier if you are willing to meet with us before September 4th).
