Farallon Consulting, L.L.C. (Farallon) has prepared this progress report on behalf of Prologis-Exchange 3301 South Norfolk LLC (Prologis) to document the activities conducted during July 2025 at the Emerald Gateway Site at 3301 South Norfolk Street in Seattle and Tukwila, Washington (herein referred to as the Site). This progress report was prepared in accordance with the requirements of Section VII(E) of Agreed Order No. DE 16659 dated January 15, 2020, between the Washington State Department of Ecology (Ecology) and Prologis (Agreed Order).

ACTIVITIES COMPLETED DURING THIS REPORTING PERIOD

The following activities were completed during this reporting period to comply with the Agreed Order:

- Farallon continued to support the general contractor during Site redevelopment. No contaminated or potentially contaminated soil was encountered during this reporting period.
- Farallon submitted an Agency Draft Remedial Investigation Work Plan to Ecology for review on July 28, 2025.
- Farallon addressed Ecology's comments and resubmitted the Interim Action Report to Ecology on July 29, 2025.
- The progress report for June 2025 was prepared and submitted.

No samples were collected during this reporting period.

Farallon anticipates conducting the following activities for the next reporting period:
