Dear Jill Macik:

The Washington State Department of Ecology (Ecology) wants you to know there have been environmental cleanup actions completed at the Block 38 West site listed above (Site). While Ecology considers the cleanup actions finished for the Site (see attached Consent Decree Status and No Further Action letter dated March 25, 2026), contamination remains in localized areas at the Site, including beneath adjacent rights-of-way (ROWs) managed by the City of Seattle. In accordance with [Consent Decree No. 25-2-01367-7 SEA](#)¹, there are environmental restrictions in place for the Block 38 West property (King County parcels 198320-0170, 198320-0180, and 198320-0196) and surrounding ROW to ensure the cleanup remains effective.

While you can continue to use your ROWs in the areas surrounding the Block 38 West property, if your activities involve removal of the asphalt or concrete cover or digging into the ground, your workers could encounter contaminated soil and potentially be put at risk. Ecology wants to ensure you are aware the property has remaining contamination requiring environmental restrictions to protect human health and the environment. Because of the remaining contamination and environmental restrictions, Ecology encourages you to discuss any proposed activities within the

boundaries of the Block 38 West property and adjacent ROWs with Ecology representatives, so they can assist you in safely conducting your activities.

What are the Environmental Restrictions?

Environmental restrictions are rules about the kinds of activities permitted at a property that is part of a site. Environmental restrictions are outlined in a document called an environmental covenant, which is attached to a property title and recorded with the County. The environmental covenant for this property is included with this letter and reflects that the landowner has agreed to restrictions on these kinds of activities:

- Any activity that will compromise the integrity of the asphalt/concrete cap including: drilling; digging; piercing the cap with sampling device, post, stake or similar device; grading; excavation; installation of underground utilities; removal of the cap; or application of loads in excess of the cap load bearing capacity is prohibited without prior written approval by Ecology.

If the restrictions are followed, the cleanup will protect people and the environment from contamination. If the restrictions are not followed, people or the environment could be exposed to contamination and repairs or additional remedial action may be required. Since these conditions may have an impact on the City's assets and activities in the affected ROW, the Consent Decree for this Site includes a contingency plan to allow for potential additional remedial actions to be taken by the potentially liable person (PLP), if required. Those actions may include additional sampling, health and safety monitoring, contamination removal, and/or repairs to the cap. Such measures would be conditions of Ecology's written approval of any plan submitted by the PLP that proposes to temporarily compromise and repair the cap in conjunction with work to be performed in the affected areas.

Ecology will review this site every 5 years, as resources permit, to make sure the cleanup and environmental restrictions still protect human health and the environment.

Worker Safety

Protection of workers from contamination is very important. Before beginning construction or maintenance at this property, call your Ecology regional office at (206) 594-0000 and ask to speak to someone in the Toxics Cleanup Program. Ecology can help you understand the specific restrictions for the property and how to make sure any activity you conduct will be done safely. The included map illustrates the location of contamination at the Site.

Environmental Covenant

Grantor: City Investors IX L.L.C.

Grantee: State of Washington, Department of Ecology (hereafter "Ecology")

Brief Legal Description: PTN LOTS 8, 9, 10, 11, 12, AND 13, BLOCK 94, DENNY'S FIRST ADD TO N SEATTLE, VOL 1, LESS ST LESS ALLEY (ALLEY DEDICATION REC NO. 2019121200065)

RECITALS

- a. This document is an environmental (restrictive) covenant (hereafter "Covenant") executed pursuant to the Model Toxics Control Act ("MTCA"), chapter 70A.305 RCW, and Uniform Environmental Covenants Act ("UECA"), chapter 64.70 RCW.
- b. The Property that is the subject of this Covenant is part or all of a site commonly known as the Block 38 West ("Site") in Seattle, Washington, Ecology Facility Site ID No. 62773, Cleanup Site ID No. 15008. The Property is legally described in Exhibit A, and illustrated in Exhibit B, both of which are attached (hereafter "Property"). If there are differences between these two Exhibits, the legal description in Exhibit A shall prevail.
- c. The Property is the subject of remedial action conducted under MTCA. This Covenant is required because residual contamination remains on the Property after completion of remedial actions. Specifically, the following principal contaminants remain on the Property:

Medium	Principal Contaminants Present
Soil	Residual total petroleum hydrocarbons as diesel- and oil-range organics (DRO and ORO); carcinogenic polycyclic aromatic hydrocarbons (cPAHs)

- d. It is the purpose of this Covenant to restrict certain activities and uses of the Property to protect human health and the environment and the integrity of remedial actions conducted at the site. Records describing the extent of residual contamination and remedial actions conducted are

available through Ecology. These include the following documents, which can be found online at <https://apps.ecology.wa.gov/cleanupsearch/site/15008>:

- Remedial Investigation and Focused Feasibility Study - December 20, 2024
- Interim Action Report (Property Cleanup) – December 28, 2023
- Alley Interim Action Report – January 5, 2024
- Cleanup Action Plan - December 2024

e. This Covenant grants Ecology certain rights under UECA and as specified in this Covenant. As a Holder of this Covenant under UECA, Ecology has an interest in real property; however, this is not an ownership interest which equates to liability under MTCA or the Comprehensive Environmental Response, Compensation, and Liability Act, 42 U.S.C. § 9601 *et seq.* The rights of Ecology as an “agency” under UECA, other than its right as a holder, are not an interest in real property.

COVENANT

City Investors IX L.L.C. as Grantor and fee simple owner of the Property hereby grants to the Washington State Department of Ecology, and its successors and assignees, the following covenants. Furthermore, it is the intent of the Grantor that such covenants shall supersede any prior interests the Grantor has in the property and run with the land and be binding on all current and future owners of any portion of, or interest in, the Property.

Section 1. General Restrictions and Requirements.

The following general restrictions and requirements shall apply to the Property:

- Interference with Remedial Action.** The Grantor shall not engage in any activity on the Property that may impact or interfere with the remedial action and any operation, maintenance, inspection or monitoring of that remedial action without prior written approval from Ecology.
- Protection of Human Health and the Environment.** The Grantor shall not engage in any activity on the Property that may threaten continued protection of human health or the environment without prior written approval from Ecology. This includes, but is not limited to, any activity that results in the release of residual contamination that was contained as a part of the remedial action or that exacerbates or creates a new exposure to residual contamination remaining on the Property.
- Continued Compliance Required.** Grantor shall not convey any interest in any portion of the Property without providing for the continued adequate and complete operation, maintenance and monitoring of remedial actions and continued compliance with this Covenant.
- Leases.** Grantor shall restrict any lease for any portion of the Property to uses and activities consistent with this Covenant.
- Preservation of Reference Monuments.** Grantor shall make a good faith effort to preserve any reference monuments and boundary markers used to define the areal extent of coverage of this Covenant. Should a monument or marker be damaged or destroyed, Grantor shall

have it replaced by a licensed professional surveyor within 30 days of discovery of the damage or destruction.

Section 2. Specific Prohibitions and Requirements.

In addition to the general restrictions in Section 1 of this Covenant, the following additional specific restrictions and requirements shall apply to the Property.

a. Containment of Soil/Waste Materials. The remedial action for the Property is based on containing contaminated soil under a cap consisting of asphalt and concrete pavement overlying areas of remaining soil contamination in the alley area east of the Property and in the Westlake Avenue North right-of-way as illustrated in Exhibit C. The primary purpose of this cap is to contain soil impacted with residual contamination to protect human health by preventing direct contact exposure. As such, the following restrictions shall apply within the area illustrated in Exhibit C:

1. Any activity on the Property that will compromise the integrity of the cap including: drilling; digging; piercing the cap with sampling device, post, stake or similar device; grading; excavation; installation of underground utilities; removal of the cap; or, application of loads in excess of the cap load bearing capacity, is prohibited without prior written approval by Ecology. The Grantor shall report to Ecology within forty-eight (48) hours of the discovery of any damage to the cap. Unless an alternative plan has been approved by Ecology in writing, the Grantor shall promptly repair the damage and submit a report documenting this work to Ecology within thirty (30) days of completing the repairs.

The Grantor covenants and agrees that it shall annually, or at another time as approved in writing by Ecology, inspect the cap and report within thirty (30) days of the inspection the condition of the cap and any changes to the cap that would impair its performance.

Section 3. Access.

a. The Grantor shall maintain clear access to all remedial action components necessary to construct, operate, inspect, monitor, and maintain the remedial action.

b. The Grantor freely and voluntarily grants Ecology and its authorized representatives, upon reasonable notice, the right to enter the Property at reasonable times to evaluate the effectiveness of this Covenant and associated remedial actions, and enforce compliance with this Covenant and those actions, including the right to take samples, inspect any remedial actions conducted on the Property, and to inspect related records.

c. No right of access or use by a third party to any portion of the Property is conveyed by this instrument.

Section 4. Notice Requirements.

a. Conveyance of Any Interest. The Grantor, when conveying any interest in any part of the property within the area of the Property illustrated in Exhibits B and C, must:

- i. Provide written notice to Ecology of the intended conveyance at least thirty (30) days in advance of the conveyance. This advance notice to Ecology is waived for conveyances of leasehold interests. Waiver of this advance notice to Ecology for these transactions does not constitute waiver of this notice for the entire Property nor a waiver of the requirement in Section 4.a.ii. to include this notice in any document conveying interest in the Property.
- ii. Include in the conveying document a notice in substantially the following form, as well as make available, upon request, a complete copy of this Covenant:

NOTICE: THIS PROPERTY IS SUBJECT TO AN ENVIRONMENTAL COVENANT GRANTED TO THE WASHINGTON STATE DEPARTMENT OF ECOLOGY ON _____ AND RECORDED WITH THE KING COUNTY AUDITOR UNDER RECORDING NUMBER _____. USES AND ACTIVITIES ON THIS PROPERTY MUST COMPLY WITH THAT COVENANT, A COMPLETE COPY OF WHICH IS AVAILABLE UPON REQUEST.

- iii. Unless otherwise agreed to in writing by Ecology, provide Ecology with a complete copy of the executed document within thirty (30) days of the date of execution of such document.
- b. **Reporting Violations.** Should the Grantor become aware of any violation of this Covenant, Grantor shall promptly report such violation in writing to Ecology.
 - c. **Emergencies.** For any emergency or significant change in site conditions due to Acts of Nature (for example, flood or fire) resulting in a violation of this Covenant, the Grantor is authorized to respond to such an event in accordance with state and federal law. The Grantor must notify Ecology in writing of the event and response actions planned or taken as soon as practical but no later than within 24 hours of the discovery of the event.
 - d. **Notification procedure.** Any required written notice, approval, reporting or other communication shall be personally delivered or sent by first class mail to the following persons. Any change in this contact information shall be submitted in writing to all parties to this Covenant. Upon mutual agreement of the parties to this Covenant, an alternative to personal delivery or first-class mail, such as e-mail or other electronic means, may be used for these communications.

Section 5. Modification or Termination.

a. Grantor must provide written notice and obtain approval from Ecology at least sixty (60) days in advance of any proposed activity or use of the Property in a manner that is inconsistent with this Covenant. For any proposal that is inconsistent with this Covenant and permanently modifies an activity or use restriction at the site:

i. Ecology must issue a public notice and provide an opportunity for the public to comment on the proposal; and

ii. If Ecology approves of the proposal, the Covenant must be amended to reflect the change before the activity or use can proceed.

b. If the conditions at the site requiring a Covenant have changed or no longer exist, then the Grantor may submit a request to Ecology that this Covenant be amended or terminated. Any amendment or termination of this Covenant must follow the procedures in MTCA and UECA and any rules promulgated under these chapters.

Section 6. Enforcement and Construction.

a. This Covenant is being freely and voluntarily granted by the Grantor.

b. Within ten (10) days of execution of this Covenant, Grantor shall provide Ecology with an original signed Covenant and proof of recording and a copy of the Covenant and proof of recording to others required by RCW 64.70.070.

c. Ecology shall be entitled to enforce the terms of this Covenant by resort to specific performance or legal process. All remedies available in this Covenant shall be in addition to any and all remedies at law or in equity, including MTCA and UECA. Enforcement of the terms of this Covenant shall be at the discretion of Ecology, and any forbearance, delay or omission to exercise its rights under this Covenant in the event of a breach of any term of this Covenant is not a waiver by Ecology of that term or of any subsequent breach of that term, or any other term in this Covenant, or of any rights of Ecology under this Covenant.

d. The Grantor shall be responsible for all costs associated with implementation of this Covenant. Furthermore, the Grantor, upon request by Ecology, shall be obligated to pay for Ecology's costs to process a request for any modification or termination of this Covenant and any approval required by this Covenant.

e. This Covenant shall be liberally construed to meet the intent of MTCA and UECA.

f. The provisions of this Covenant shall be severable. If any provision in this Covenant or its application to any person or circumstance is held invalid, the remainder of this Covenant or its application to any person or circumstance is not affected and shall continue in full force and effect as though such void provision had not been contained herein.

g. A heading used at the beginning of any section or paragraph or exhibit of this Covenant may be used to aid in the interpretation of that section or paragraph or exhibit but does not override the specific requirements in that section or paragraph.

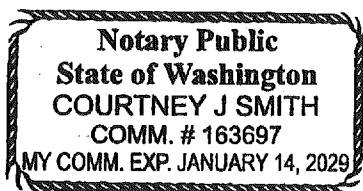

PROPERTY MAP

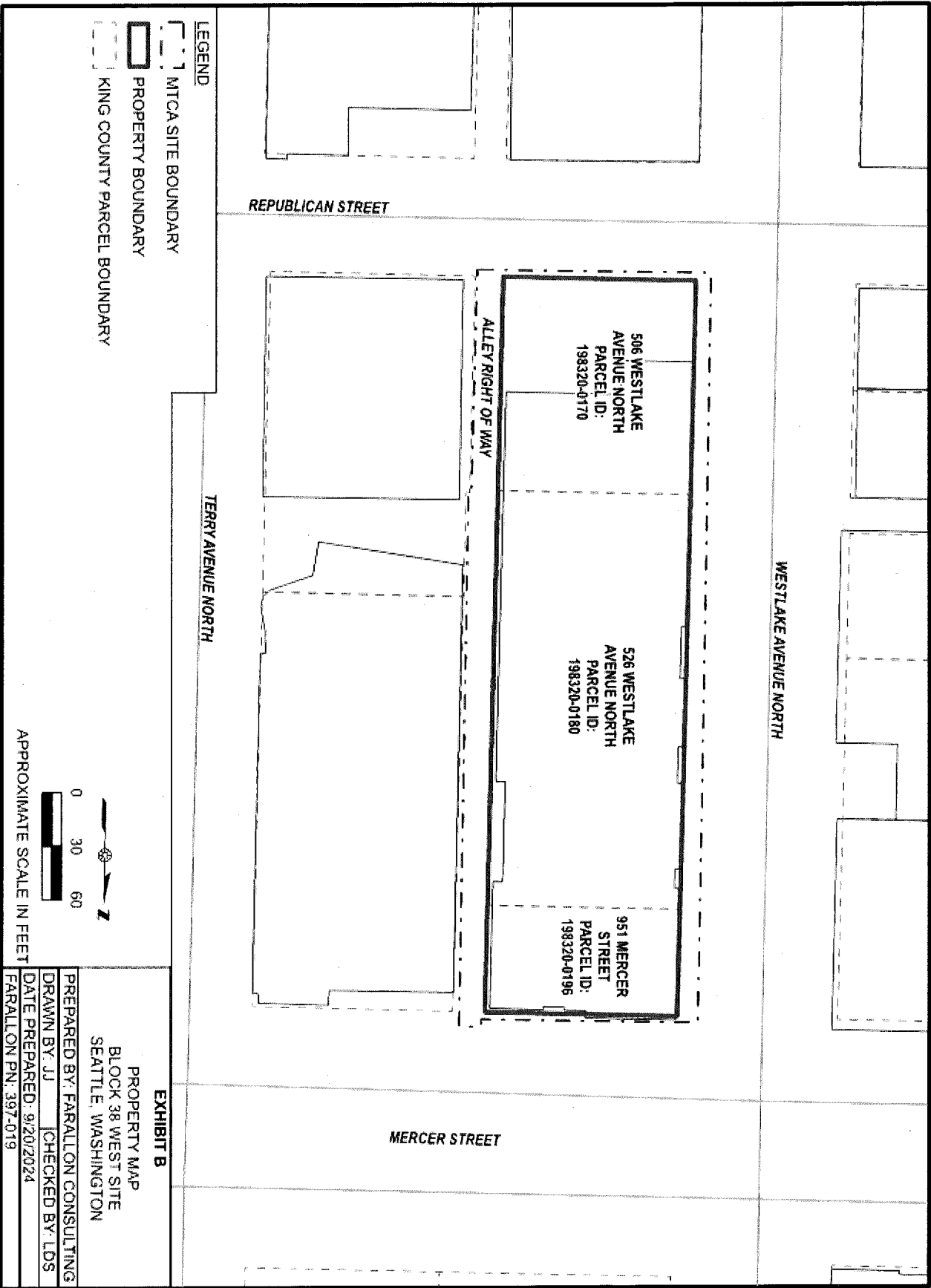
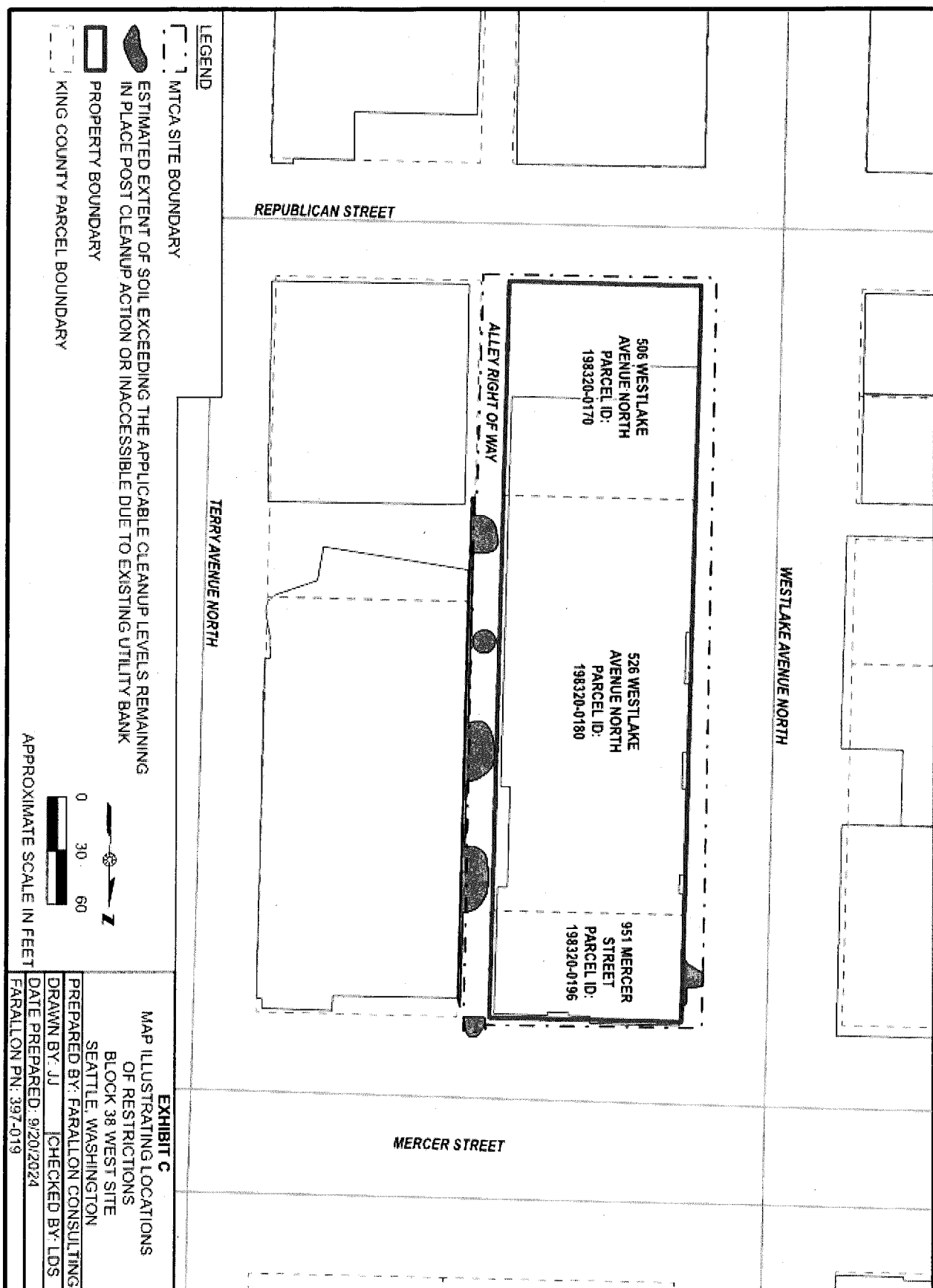

Thank you for working with the Washington State Department of Ecology (Ecology) on Block 38 West (Site) under the Model Toxics Control Act (MTCA), Chapter 70A.305 RCW, and Consent Decree No. 25-2-01367-7 SEA (Decree), which became effective on January 17, 2025.

This letter provides written notification that, under MTCA and the Decree, no further remedial action is necessary to clean up contamination at the Site, but further remedial action is still necessary to control and monitor the remaining contamination and periodically review conditions at the Site. This letter also describes the status of the Decree and the Site.

Completion of Cleanup Required by Decree

The remedial actions required by the Decree are specified in Section VI (Work to Be Performed) and detailed in the Cleanup Action Plan (Exhibit B). City Investors IX L.L.C. (City Investors) was required to implement institutional controls by recording an environmental covenant that meets the requirements of WAC 173-340-440(8), (9), and (10) and RCW 64.70 (Uniform

Environmental Covenants Act). An environmental covenant has been recorded by King County (Instrument No. 20250730000335), which imposes certain restrictions on the activities and uses of the Block 38 West property and surrounding right-of-way to protect human health, the environment, and the integrity of the remedial actions completed to date at the Site. After inspecting the Site and reviewing the supporting documentation, Ecology has determined that the cleanup required at the Site under the Decree has been satisfactorily completed.

Post-Cleanup Remedial Actions Required by Decree

Although the cleanup of contamination at the Site has been completed, further remedial action is still necessary under MTCA and required under the Decree to control and monitor the remaining contamination at the Site. City Investors' responsibilities are specified in Section VI (Work to Be Performed) of the Decree and detailed in the Compliance Monitoring Plan, which is provided in Appendix A of the Cleanup Action Plan (Exhibit B of the Decree).

Periodic Reviews of Post-Cleanup Conditions Required by Decree

Ecology will conduct periodic reviews of post-cleanup conditions at the Site to ensure they remain protective of human health and the environment. This requires continued access to the Site, as provided in Section IX (Access) of the Decree. City Investors' responsibilities are specified in Section XXIV (Periodic Review) of the Decree. Any costs incurred by Ecology in conducting periodic reviews may be recovered from City Investors.

Status of Decree

Although the cleanup of contamination at the Site has been completed, further remedial action is still necessary under MTCA and required by the Decree to control and monitor the remaining contamination and periodically review the conditions at the Site. The Decree will remain in effect until the required post-cleanup remedial actions are completed or are no longer necessary under MTCA.

This letter summarizes City Investors' remaining responsibilities under the Decree; it does not alter or expand City Investors' responsibilities under the Decree.

No Further Action Determination

Ecology has determined that no further remedial action is necessary to clean up contamination at the Site under MTCA. However, as explained above, further remedial action is still necessary under MTCA to control and monitor the remaining contamination and periodically review the conditions at the Site.

Delisting of the Site

Based on the no further action determination, Ecology proposed removing the Site from the Contaminated Sites List (CSL). Ecology published notice of the proposal in the Site Register on November 13, 2025 and provided a 30-day public comment period, from November 17, 2025 to December 16, 2025. Comments were received from one party. After review and consideration of the comments, Ecology will remove the Site from the CSL **effective the date of this letter**. The removal will be reflected in the next publication of the CSL in the Site Register.

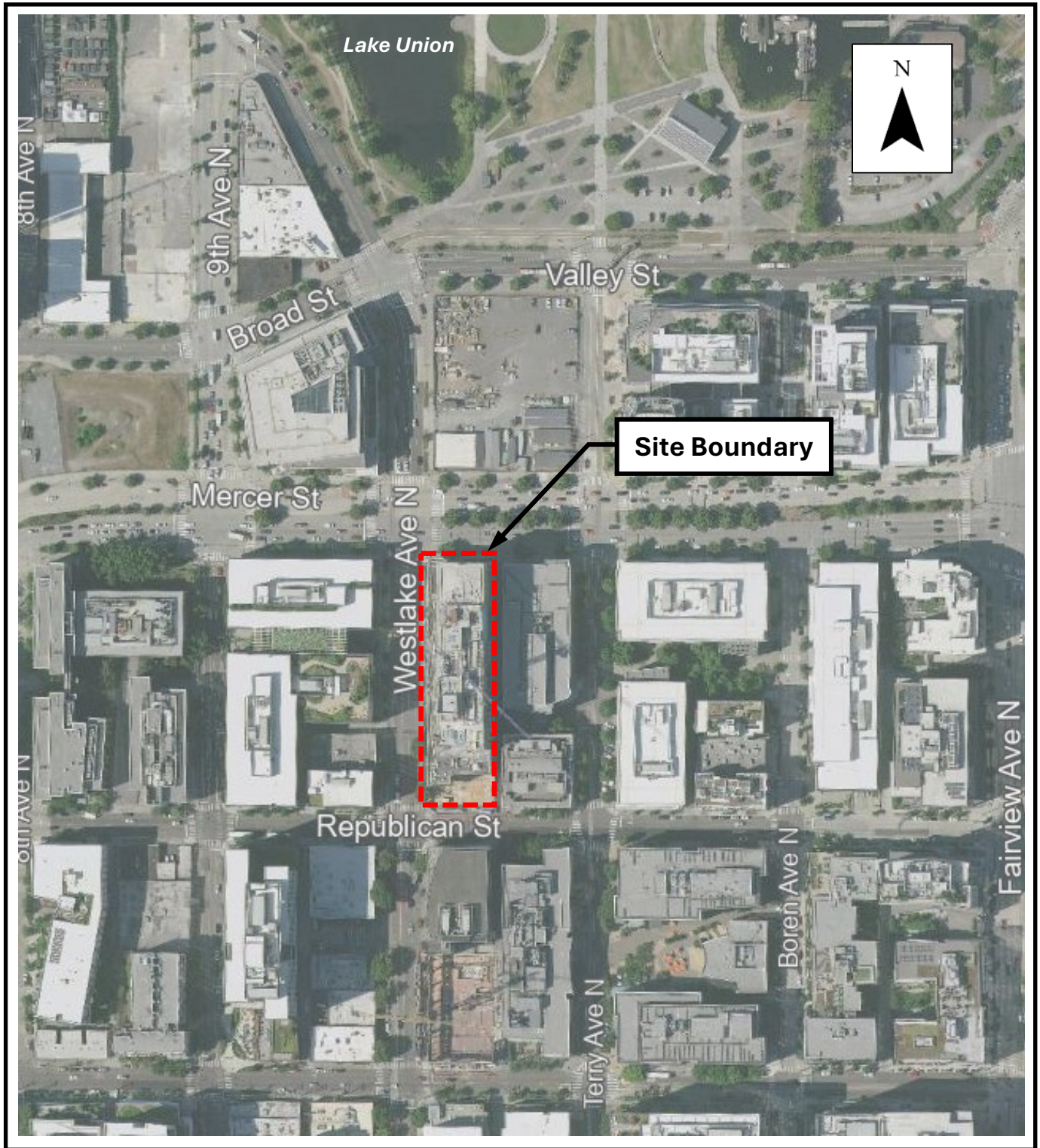
