

## **Second Amendment to the Agreed Order for Bothell Riverside**

Washington State Department of Ecology (Ecology) and City of Bothell (City), a Potentially Liable Party (PLP) for the site are amending the 2009 Agreed Order for the Bothell Riverside cleanup site. This second Amendment to Agreed Order 6295 requires a second interim action to prevent the chlorinated solvents in the groundwater from discharging into the Sammamish River. Bothell Riverside is located at NE 180<sup>th</sup> Street and Woodinville Drive, Bothell, WA.

With this second amendment to the Agreed Order, the City of Bothell agrees to conduct additional interim action activities at the site which include:

- installing four extraction wells to collect and discharge solvent contaminated groundwater into the sanitary sewer. The City will obtain the appropriate permits required.
- submitting ground water monitoring reports.

Ecology has reviewed the interim action work plan, schedule and State Environmental Policy Act which are also available for public review.

### **State Environmental Policy Act (SEPA) Checklist and Determination of Non-Significance (DNS)**

The SEPA environmental checklist and Determination of Non-Significance (DNS) are also available for public review at this time. This checklist evaluates potential environmental impacts if these interim cleanup actions are conducted. Ecology has reviewed this checklist and determined that no significant adverse environmental impacts will be caused by these interim remedial actions.

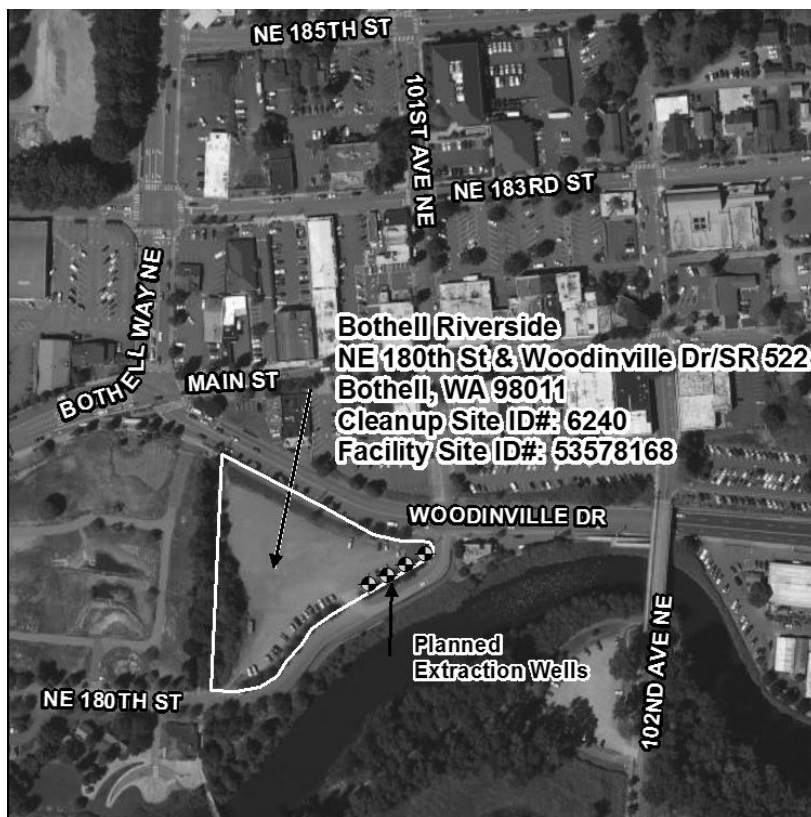

### Site Background



The site contained a former gasoline service station. An environmental study in 2008 documented the presence of petroleum contaminants in the soil as well as chlorinated solvents in the groundwater at levels of potential concern. Petroleum impacted soil and groundwater were found chiefly at the northwestern portion of the property boundary.

The City conducted a first interim action in 2010 under the first amendment to the Agreed Order. The City excavated and properly disposed of the petroleum contaminated soil off site. Soil samples collected at the limits of the excavation confirmed that the petroleum contamination which was the subject of the first interim action was removed.

This second proposed interim action will prevent the solvent contaminated groundwater from flowing into Sammamish River.

## Bothell Riverside

### Why Does this Matter?

This will protect people from any potential exposure to groundwater, and protect the water quality of the Sammamish River that receives groundwater discharge from the site.

### What Happens Next?

After the public comment period ends, Ecology will read and consider all comments that were received. A public meeting is not planned for this site. However a meeting will be held if 10 or more people request it.

El Departamento de Ecología del Estado de Washington (Ecología) les invita hacer comentarios referente a la segunda Enmienda a la Orden Acordada para el sitio “Bothell Riverside”  
Periodo de Comentarios Públicos: 1 de marzo – 1 de abril, 2013

La Ciudad de Bothell (Ciudad) es una Entidad Posiblemente Responsable (PLP, por sus siglas en inglés) para la contaminación del sitio. Ecología y la Ciudad están enmendando la Orden Acordada de 2009 para la limpieza del sitio “Bothell Riverside”. Esta segunda Enmienda requiere una segunda acción provisional para prevenir que los solventes clóricos presentes en el agua subterránea descargan al Río Sammamish. El sitio “Bothell Riverside” está ubicado cerca la intersección de “NE 180<sup>th</sup> Street” y “Woodinville Drive”, en la Ciudad de Bothell, WA.

Según esta segunda Enmienda a la Orden Acordada, la Ciudad está de acuerdo con hacer actividades adicionales de acción provisional en el sitio que incluirán las siguientes:

- la instalación de cuatro pozos de extracción para recoger el agua subterránea contaminada con solventes y descargarla a la alcantarilla sanitaria. La Ciudad obtendrá los permisos requeridos apropiados.
- la entrega de reportes de monitoreo del agua subterránea.

Ecología ha revisado el plan de trabajo de acción provisional, el horario y el cumplimiento con la Ley Estatal de la Política Ambiental (SEPA) que también está disponible para la revisión pública. Ecología determinó que las propuestas acciones de SEPA no tendrán un impacto adverso significativo para el medio ambiente. Por lo tanto, Ecología ha emitido una Determinación de Impacto Insignificante.
