

## Proposed Removal from the Hazardous Sites List

The Department of Ecology (Ecology) proposes taking Hytec Littlerock off the Hazardous Sites List. You may comment on this from **June 13 - July 15, 2013**. The box to the right shows where to find:

- Draft letters to Mr. and Mrs. Lufkin and Hytec, the site owners, approving the Hytec Littlerock and Bordeaux Dump cleanups.
- The Cleanup Action Plan and Remedial Action Plan, which describe how Hytec and the Lufkins cleaned up the sites.
- Fact sheets with history about the sites and cleanup process.

### Background

The sites are located at 13434 SW Halo Kuntux Lane in Littlerock. Mr. Lufkin, who was president of the fiberglass manufacturer Hytec, Inc., purchased the property in 1975.

**Hytec Littlerock:** From 1976, the company buried fiberglass and polyester resin waste on the north part of the property. Soil and groundwater were contaminated with naphthalene, lead, and semi-volatile organic compounds.

**Bordeaux Dump:** During the site investigation, another contaminated area was found southeast of the fiberglass landfill. This area had been used as a dump site, likely for the former logging town of Bordeaux.

### Cleanup Actions

The owners removed contaminated soil and debris, filled the areas with clean soil, and sampled soil to make sure the site was clean. They then monitored groundwater for one year and found no contaminants above state cleanup levels.

### What Happens Next

At the end of the comment period, Ecology will respond to comments in a responsiveness summary. We will send this document to those who commented and post it online. We will also finalize the cleanup approval letters and send them to the Lufkins and Hytec. The last step is to remove the Hytec Littlerock site from the Hazardous Sites List.

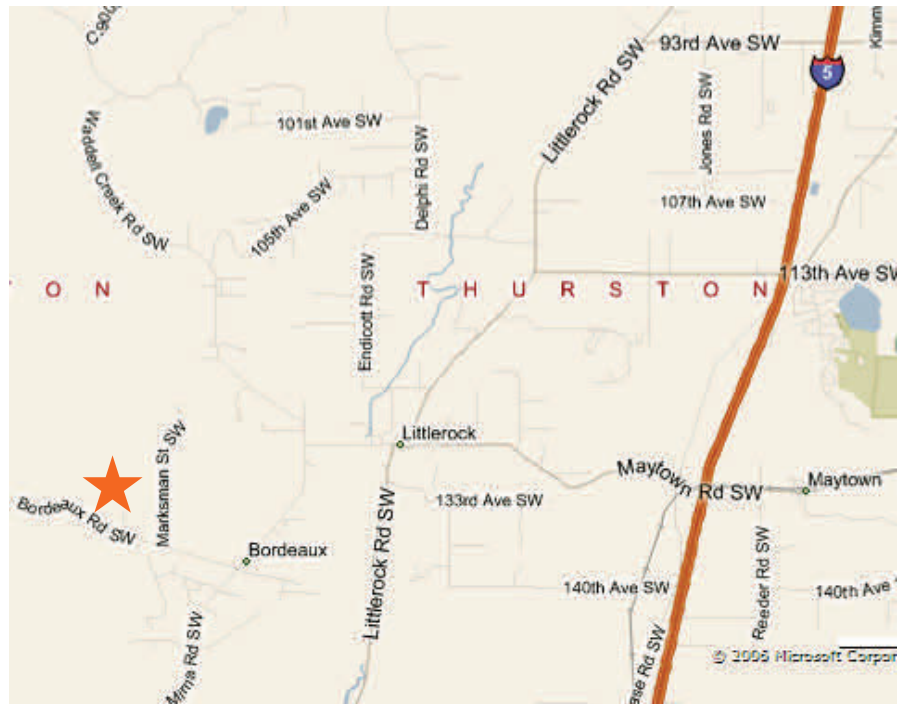
