# INTRODUCTION

The Washington State Department of Ecology (Ecology) has developed this Public Participation Plan in pursuant to the state cleanup regulation called the Model Toxics Control Act (MTCA) WAC 173-340-600. The intent is to promote meaningful community involvement during the cleanup process at the Cornet Bay Marina Site located at 200 Cornet Bay Road in Oak Harbor, Washington. This plan outlines and describes the tools that Ecology uses to inform the public about site activities and identifies opportunities for the community to become involved.

# SITE BACKGROUND

The Cornet Bay Marina Site is associated with a marina located on 200 Cornet Bay Road in Oak Harbor on Whidbey Island. It is bounded on the west by Cornet Bay and on the east by Cornet Bay Road and mixed residential homes and light commercial land uses. Deception Pass State Park is immediately adjacent to the north of the Site. The marina was constructed in the 1960s and has been operated as a marina and general store since then. The Site, which covers approximately 1.1 acres of upland property, includes a store building, a gravel parking lot, a 330-foot-long aging wooden bulkhead that separates the upland facility from the marina. Fuel is provided to boats via a vaulted underground storage tank.

# **Chemicals of Concern**

Soil and groundwater has been contaminated by petroleum from several fuel line releases during 1989. Contamination has been spread almost across the entire property over the years. The known contaminants in soil and groundwater include:

- Gasoline
- Diesel fuel
- Benzene, toluene, ethylbenzene, xylene (BTEX)

# **Regulatory Status and Proposed Cleanup Actions**

A consent decree was signed between Ecology and the property owner in 1993 to conduct site characterization and cleanup. A remedial investigation/feasibility study and cleanup action plan are requirements under the consent decree. Several site investigations have been conducted over the years as funding was available and the extent of the contamination has been delineated. Ecology has received sufficient funding to clean up this Site during the 2013-2015 biennium. The proposed cleanup activities will include:

• Installation of a new sheet pile and demolition of the existing bulkhead

A new steel sheet pile bulkhead will be installed in front of the existing bulkhead waterward to ensure that all the contaminated soil in the vicinity of

the existing bulkhead can be safely excavated. The existing timber bulkhead will be cut off at the mudline or deeper, depending on the depth of excavation.

Upland Excavation

This will involve excavation of all petroleum contaminated soil to the maximum extent practicable from the upland area and off-site disposal. The excavation will be backfilled using clean fill material. Construction dewatering water and stormwater will be collected and treated on-site and discharged to Cornet Bay under a NPDES permit. Confirmation sampling will be conducted to demonstrate compliance with cleanup levels.

- Temporary platforms will be constructed to ensure that the marina will be accessible during construction. The store building will be relocated in order to excavate the contaminated soil beneath it, and it will be placed back to its original location following excavation. Water and electricity will be temporarily re-routed. The fuel line might be temporarily shut down during construction.
- Work on the bulkhead is scheduled to begin this fall, followed by soil excavation. The construction is anticipated to be completed by the end of 2013, followed by groundwater compliance monitoring.

# PUBLC PARTICIPATION ACTIVITIES AND RESPONSIBILITIES

#### **Public Involvement Activities**

Ecology uses a variety of activities to facilitate public participation in the investigation and cleanup of MTCA sites. Ecology will take into consideration input provided by the community. This list details the public involvement activities that Ecology will use, their purposes, and descriptions of when and how they will be used during this site cleanup.

# **Formal Public Comment Periods**

Comment periods are the primary method Ecology uses to get feedback from the public on proposed cleanup decisions. Comment periods usually last 30 days and are required at key points during the investigation and evaluation of proposed cleanup process before final decisions are made.

During a comment period, the public can comment in writing or email. At the conclusion of the comment period, Ecology reviews all comments and may respond in a document called a Responsiveness Summary.

Ecology will consider the need for changes or revisions based on input from the public. If significant changes are made, then a second comment period will be held. If no significant changes are made, then the draft document(s) will be finalized.

Also, if ten or more people request a public meeting during the 30 day comment period, Ecology will hold a public meeting for the purpose of taking comments on draft documents.

#### PUBLIC PARTICIPATION PLAN AMENDMENTS

The Plan was developed by Ecology and complies with the MTCA regulations (Chapter 173-340 WAC). It will be reviewed as cleanup progresses and may be amended if necessary. Amendments may be submitted to Ecology's site manager, Jing Liu, for review and consideration.

#### GLOSSARY

**Cleanup:** Actions taken to deal with a release, or threatened release of hazardous substances that could affect public health and/or the environment. The term "cleanup" is often used broadly to describe various response actions or phases of remedial responses such as the remedial investigation/feasibility study.

**Comment Period:** A time period during which the public can review and comment on various documents and proposed actions. For example, a comment period may be provided to allow community members to review and comment on proposed cleanup action alternatives and proposed plans.

**Information Repository:** A file containing current information, technical reports, and reference documents available for public review. The information repository is usually located in a public building that is convenient for local residents such as a public school, city hall, or library.

**Model Toxics Control Act (MTCA)**: Legislation passed by the State of Washington in 1988. Its purpose is to identify, investigate, and clean up facilities where hazardous substances have been released. It defines the role of Ecology and encourages public involvement in the decision making process. MTCA regulations became effective March 1, 1989 and are administered by the Washington State Department of Ecology.

**Public Notice:** At a minimum, adequate notice mailed to all persons who have made a timely request of Ecology and to persons residing in the potentially affected vicinity of the proposed action; mailed to appropriate news media; published in the local (city and county) newspaper of largest circulation; and the opportunity for the interested persons to comment.

**Public Participation Plan:** A plan prepared under the authority of WAC 173-340-600 to encourage coordinated and effective public involvement tailored to the public's needs at a particular site.

**Responsiveness Summary:** A summary of oral and/or written public comments received by Ecology during a comment period on key documents, and Ecology's responses to those comments.

**Site:** Any building, structure, installation, equipment, pipe or pipeline (including any pipe into a sewer or publicly owned treatment works), well, pit, pond, lagoon, impoundment, ditch, landfill, storage container, motor vehicle, rolling stock, vessel, or aircraft; or any site or area where a hazardous substance, other than a consumer product in consumer use, has been deposited, stored, disposed of, or placed, or otherwise come to be located.

**Site Register:** Publication issued every two weeks of major activities conducted statewide related to the study and cleanup of hazardous waste sites under the Model Toxics Control Act. To receive this publication, please call (360) 407-7200.
