As you are aware, the Washington State Department of Ecology (Ecology) has overseen the investigation, remedial activities, and groundwater monitoring that have taken place under Consent Decree No. 10-2-01899-6 at the Hytec Little Rock – Fiberglass Debris Landfill Site located at 13434 S.W. Halo Kuntux Lane Olympia, WA. This letter is to notify you that the clean-up actions and monitoring required in Consent Decree No. 10-2-01899-6 have been successfully completed under Chapter 173-340 WAC and the Model Toxics Control Act (MTCA), in accordance with the December, 2009 Cleanup Action Plan for this Site.

Under the Consent Decree, soil cleanup activities included:

- Removing approximately 4,300 cubic yards of contaminated soil and debris, and filling the areas with clean soil.
- Sampling soil to make sure all contaminated soil and debris were removed.

In addition, post-cleanup groundwater monitoring was performed for one year to confirm MTCA cleanup levels had been achieved.

Ecology issued a fact sheet dated June 2013 stating preliminary approval of the remedial action for the site, subject to a 30-day public comment period regarding the completion of the site cleanup and removal from the Hazardous Sites List.



This completes the remedial action requirements of Consent Decree No. 10-2-01899-6, and no additional remedial action or monitoring is necessary at this site. Ecology will update its database to reflect this determination. This site will not appear in future publications of the Hazardous Sites List.
