

## **Remedial Investigation/ Feasibility Study Available for Public Comment and Review**

The Washington State Department of Ecology (Ecology) is providing an opportunity for the public to comment on the Remedial Investigation/ Feasibility Study (RI/FS) for the Bee Jay Scales site (Site).

### **What is a RI/FS?**

The purpose of a Remedial Investigation is to determine the nature and extent of the release of hazardous substances at the Site and to gather necessary data to support the Feasibility Study. The purpose of the Feasibility Study is to develop and evaluate cleanup action alternatives for the Site. Ecology will use the completed RI/FS to develop a Cleanup Action Plan.

Ecology is asking for your comments on the Remedial Investigation/Feasibility Study. You are invited to:

- Review the Remedial Investigation/Feasibility Study Report.

### **Site Background**

The Site is located at 116 North 1st Street in Sunnyside, Washington. The Site and neighboring properties have been the location of agricultural warehouses, lumber yards, coal storage, and railroad activities since 1906. The site is currently owned by Hickenbottom & Sons, Inc. and run by Bee Jay Scales, Inc. A 1990 report informed Ecology of pesticides, fertilizers, and
