Lot 2 of Sunnydell Large Lot Subdivision, recorded January 23, 2013 in Volume 2 of Large Lot Subdivisions,

page 43, records of Clallam County, Washington.

Grantor, Ellen Dryke, hereby binds Grantor, its successors and assigns to the land use restrictions identified herein and grants such other rights under this environmental covenant (hereafter "Covenant") made this 16th day of October, 2013 in favor of the State of Washington Department of Ecology (Ecology). Ecology shall have full right of enforcement of the rights conveyed under this Covenant pursuant to the Model Toxics Control Act, RCW 70.105D.030(1)(g), and the Uniform Environmental Covenants Act, 2007 Wash. Laws ch. 64.70 RCW.

This Declaration of Covenant is made pursuant to RCW 70.105D.030(1)(f) and (g) and WAC 173-340-440 by Ellen Dryke, its successors and assigns, and the State of Washington Department of Ecology, its successors and assigns (hereafter "Ecology").

A remedial action (hereafter "Remedial Action") occurred at the property that is the subject of this Covenant. The Remedial Action conducted at the property is described in the following document[s]:

Remedial Action Work Plan, dated September 19, 2013

These documents are on file at Ecology's Southwest Regional Office

This Restrictive Covenant is required because lead and PAH's continue to exist at this active shooting range. While periodic lead recycling and Best Management Practices will both mitigate buildup of lead and maintain proper management controls, an environmental covenant is necessary to protect human health and the environment.

The undersigned, Ellen Dryke, is the owner of real property (hereafter "Property") in the County of Clallam, State of Washington, that is subject to this Covenant. The Property is legally described AS FOLLOWS:

Lot 2 of Sunnydell Large Lot Subdivision, recorded January 23, 2013 in Volume 2 of Large Lot Subdivisions, page 43, records of Clallam County, Washington.

Ellen Dryke makes the following declaration as to limitations, restrictions, and uses to which the Property may be put and specifies that such declarations shall constitute covenants to run with the land, as provided by law and shall be binding on all parties and all persons claiming under them, including all current and future owners of any portion of or interest in the Property (hereafter "Owner") as long as the use of the property remains as a shooting range. If the use of Lot 2 of Sunnydell Large Lot Subdivision, recorded January 23, 2013 in Volume 2 of Large Lot Subdivisions, page 43, records of Clallam County, Washington changes, additional investigation and/or cleanup will be necessary.

The Owner of the property must give thirty (30) day advance written notice to Ecology of the Owner's intent to convey any interest in the Property.

The Owner of the Property reserves the right under WAC 173-340-440 to record an instrument that provides that this Covenant shall no longer limit use of the Property or be of any further force or effect. However, such an instrument may be recorded only if Ecology concurs.


