## Site Cleanup – Engineering Design Report, SEPA Determination

The Washington State Department of Ecology (Ecology) has entered into an Agreed Order with Chevron Products Company and Burlington Northern Santa Fe Railway Company (liable parties) for implementation of a cleanup action plan for the Glacier Park - East site located to the east and north of Highway 2 and Chumstick Highway 209 in Leavenworth, Washington. An Agreed Order is a document agreed to by all parties that sets forth the activities that will occur to clean the site up. In complying with this Order, the liable parties have submitted to Ecology the Engineering Design Report (EDR) and the State Environmental Policy Act (SEPA) Checklist.

### Site Background

For more than 40 years petroleum fuel has been stored and distributed from this site. Incidental spills and leaks have contaminated the soils and groundwater at the site. To determine the source of contamination, estimate the extent of contamination, and evaluate cleanup options, a Remedial Investigation and Feasibility Study (RI/FS) was completed at this site during June 1997.

### Engineering Design Report

According to the EDR, groundwater will be sampled quarterly for the first two years, maybe longer, depending on the results. Also, approximately 67% of the site will be

covered with an asphalt cap. The EDR provides the details for construction and implementation of these activities. Work may begin during mid-September due to the impending inclement weather conditions which may delay implementation of these actions, making it necessary for work to begin as soon as possible.

### SEPA Checklist

Based upon a review of this checklist, Ecology is issuing a Determination of Non-Significance (DNS) under the State Environmental Policy Act (SEPA, Chapter 197-11 WAC) Rules. Ecology has determined that the proposed cleanup actions will not have a probable adverse impact on the environment.

### How Can You Be Involved?

You are invited to review and submit written comments on the Engineering Design Report and/or the SEPA Checklist. **The 30-day public comment period will run from September 16, 2002 to October 16, 2002.** Ecology will respond to all comments received. Revisions to the actions will be made if necessary, even though work is occurring concurrently with the public comment period. The public is encouraged to participate in this process.
