

Proposed Removal from the Hazardous Sites List

The Department of Ecology proposes taking the Brumfield Twidwell site, located at 301 E Pioneer Ave. in Montesano, off the Hazardous Sites List. You may comment on this decision **February 6 - March 10, 2014**. The box to the right shows where to find:

- A letter approving the cleanup.
- The remedial action report, which describes how the site was cleaned up and why we believe cleanup is complete.
- Fact sheets and reports about the site history and cleanup.

Site Cleanup

In the past, the site was used as an auto dealership, service station, and repair shop. In 2005, Ecology discovered petroleum contamination in site soil and groundwater during our Montesano groundwater study (see website).

From 2005 - 2006, the owner removed contaminated soil and an underground storage tank. In 2012, the owner treated remaining contamination to naturally break down the chemicals into less toxic substances. They also placed an environmental covenant on the property.

From 2012 - 2013, the owner sampled to ensure no sources remain on the property or are causing contamination above cleanup levels. Ecology has now determined that the cleanup is complete.

What Happens Next

After the comment period, we will respond to comments in a responsiveness summary. We will send this to those who commented and post it on our website. The last step is to remove the site from the Hazardous Sites List.

What is the Hazardous Sites List?



The Hazardous Sites List includes sites that Ecology has assessed for their risk to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.

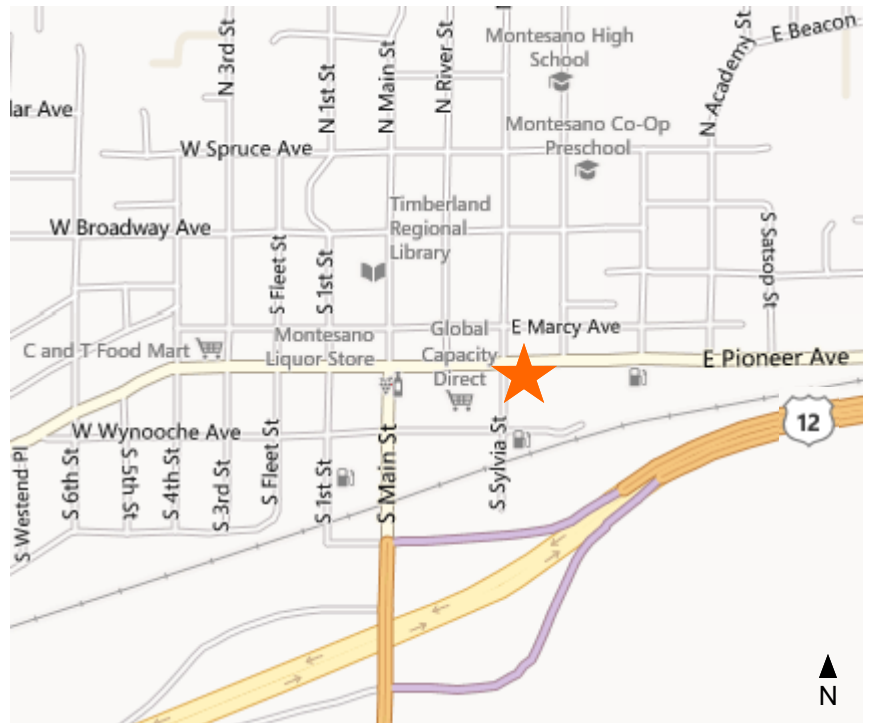
