The State Department of Ecology has recently completed a hazard ranking for the Tiger Oil contaminated site located on North First Street, Yakima, Washington, as required by the Model Toxics Control Act (RCW 70.105D). This is a comparative estimate of the potential threat of this site to human health and the environment relative to other Washington State sites ranked up to this time. A tentative ranking of 3 has been calculated for this site, (1 = high, 5 = low).

For your information, Ecology has published, as required, the ranking of this and other sites in the August 27th "Site Register". The rankings are used in conjunction with other considerations in determining our priority for followup work.
