

# CASCADE NATURAL GAS, Yakima County



## What Do You Think of the RI/FS?

Do you remember seeing a drilling rig in the parking lot of Cascade Natural Gas this summer? The sampling results and options for the site are included in the draft Remedial Investigation/Feasibility Study (RI/FS) now available for your review and comment.

Cascade Natural Gas Corporation signed an agreed order to perform the RI/FS, and do the following work:

- take soil and groundwater samples and test for contamination from petroleum products, and solvents.
- determine the groundwater levels in the wells and drains
- evaluate the county drain for any contamination

Based on the sampling results, further work may include monitoring the groundwater for three years, and taking no further action if the groundwater is clean.

## How Can You Be Involved?

You are invited to review and comment on the draft Remedial Investigation/Feasibility Study through February 3, 1995. The draft can be reviewed at the Sunnyside City Library and at Ecology's Central Regional Office. Send your written

comments to Ecology's site manager, Don Abbott. Don will review and respond to all comments received; the draft RI/FS will be revised if necessary, and a decision will be made on what cleanup actions will occur at the site.

You will be kept informed on site updates.

## Site Background

Cascade Natural Gas leased and later bought the property at 512 East Decatur Avenue from Yakima County. Soil and groundwater contamination was discovered when underground storage tanks were removed.

Cascade Natural Gas voluntarily took action on investigating and cleaning up the soil contamination from petroleum products, solvents.
