St. Paul and Pacific Railroad; thence South 06°44'03" West along said easterly right of way line for 2476.08 feet, to the north line of the south 165 feet of the southwest quarter of the southwest quarter of said Section 17; thence South 88°19'34" East for 713.10 feet along said north line to the intersection with the east line of said southwest quarter of the southwest quarter, thence South 00°31'34" West for 165.02 feet along said east line to the southeast corner of said subdivision; thence South 88°19'34" East for 375.27 feet, along the south line of the southeast quarter of the southwest quarter of said Section 17, to the intersection with the westerly right of way line of the Burlington Northern Railroad 100.00 feet west as measured perpendicular from the centerline thereof; thence North 16°52'11" East for 2869.75 feet. along said westerly right of way line; thence South 73°07'49" East perpendicular to the centerline of said Burlington Northern Railroad to a point 50.00 feet west of said centerline as measured perpendicular therefrom; thence North 16°52'11" East for 660.52 feet, along the westerly 50,00 foot right of way line of the Burlington Northern Railroad, to the intersection with the southerly right of way line of Floral Street; thence North 89°28'59" West 156.32 feet along said southerly line; thence North 73°07'49" West perpendicular to South Tower Avenue for 38,00 feet to the northwesterly right of way line thereof; thence North 16°52'11" East 131,00 feet along said northwesterly line; thence North 73°07'49" West for 30,00 feet; thence South 16°52'11" West for 392.00 feet, to the southeast corner of that parcel described by Statutory Warranty Deed recorded in Volume 216 of the Official Records of Lewis County at page 239; thence North 73°07'49" West for 485.00 feet along the south line of said parcel to the southwest corner thereof; thence North 16°52'11" East for 590.00 feet along the west line of said parcel and along the west line of a parcel described in Volume 258 of the Official Records of Lewis County at page 401 to the northwest corner of the latter mentioned parcel; thence North 73°07'49" West 23.48 feet to the intersection with the East line of that parcel described in Volume 176 of the Official Record of Lewis County at page 340; thence South 01°39'56" West along said East line for 5.34 feet to the southeast corner thereof: thence North 88°20'04" West 165.00 feet perpendicular to Woodland Avenue, to the intersection with the East line of South Side Addition; thence South 01°39'56" West 424.91 feet along said East line and said line extended to the southeast corner of that parcel described in Volume 224 of the Official Records of Lewis County at page 293 under Auditor's File Number 877620; thence North 88°20'04" West for 350.07 feet along the south line of said parcel and said line extended to the West line of Woodland Avenue; thence South 01°39'56" West along said West line for 40.00 feet; thence South 88°20'04" East for 350,07 feet; thence South 15°32'57" West 780.12 feet to the intersection with the north line

of the southwest quarter of said Section 17; thence North 88°20'00" West along said north line for 868.48 feet to the Point of Beginning. Containing 91.89 acres.

NOTE: The legal description above includes the Floral Avenue and Burlington Northern parcels that were purchased and added to the landfill. The former Centralians Inc. property is not proposed for inclusion in this deed covenant.
