
Don Oline used the site as a salvage yard. This resulted in waste chemicals and petroleum products building up at the site. Polychlorinated biphenyls (PCBs) are in some surface concrete and soil on site. There are also several small areas where surface soil is stained with petroleum hydrocarbons. Groundwater is not contaminated.

The draft cleanup plan calls for excavation of these areas. The Estate of Don Oline will dispose of the polluted soil and concrete at an approved facility.

From April 21 through May 21, 2014 the Department of Ecology (Ecology) held a public comment period for the Oline Storage Yard cleanup site.

Ecology put the following documents out for public comment:

- **Draft Agreed Order Amendment and Draft Cleanup Action Plan (CAP)** The agreed order amendment is a legal agreement that requires the Estate of Don Oline to clean up the site. The CAP outlines the recommended cleanup.
- **Remedial Investigation Report (RI)** determines the nature and extent of contamination. Based on the data from the remedial investigation, Ecology decided the two areas needing clean up are limited. The proposed cleanup alternative is the simplest and most efficient approach, and a feasibility study was not needed.
- **Updated Public Participation Plan** describes the tools Ecology will use to inform the public and gather feedback.
- State Environmental Policy Act (SEPA) review describes the potential environmental impact of the cleanup work.
