Responsiveness Summary

The Washington State Department of Ecology (Ecology) held a 30-day public comment period from July 28 through August 26, 2014 for the Interim Action proposal to address floating petroleum product identified southeast of the Airport Kwik Stop. The documents for review included: *Draft Work Plan Supplemental Interim Action Airport Kwik Stop Site Ione, Washington; State Environmental Policy Act (SEPA); and Determination of Non-Significance (DNS)*. The purpose of this Responsiveness Summary is to document Ecology's responses to comments submitted during the public comment period.

Ecology would like to thank those who commented. Based on the comment received, no changes will be required to the Work Plan to delineate the extent of the floating product and conduct a pilot test for the removal of the floating product from the ground water beneath the Site. The Interim Action Work Plan is therefore final.

The proposed supplemental interim action will delineate the petroleum fuels floating on the groundwater and conduct a pilot test to remove the floating product. All work will be conducted under the authority of the Model Toxics Control Act (MTCA) Cleanup Regulations (chapter 173-340 WAC). The proposed interim action will reduce the petroleum contamination identified floating on groundwater beneath a property located southeast of the Airport Kwik Stop, thus reducing groundwater contamination, and reducing the threat to shallow domestic water wells in the immediate area. As part of the interim action a skimmer pump will be used to remove floating product from the ground water. All product recovered as a result of the interim action will be removed from the Site and disposed/recycled.
