## RE: EARLY NOTICE LETTER Site #10579 Darrington Exxon 1025 Darrington Street Darrington, WA

On July 19, 2006 the Department of Ecology (Ecology) sampled a groundwater monitoring well and identified that there had been a release of petroleum product at the above referenced property. It is our understanding that Mr. William H. Terry is the current owner/operator of this property/facility.

Under the Model Toxics Control Act (MTCA) [Chapter 70.105D Revised Code of Washington (RCW)], Ecology maintains a database of known or suspected contaminated sites. Based on available information, the above referenced property will be added to the Leaking Underground Storage Tank (LUST) database. Please note that inclusion in the database does not mean Ecology has determined you are a potentially liable person under MTCA [administered under Chapter 173-340 of the Washington Administrative Code (WAC)].

Based on the analysis of the groundwater sampled from the monitoring well, groundwater remains above the Model Toxics Control Act (MTCA) Method A Cleanup Levels for Total Petroleum Hydrocarbons. Since Ecology has verified groundwater impacts, the site status on the LUST database is being categorized as "Awaiting Cleanup". Please be aware that this status does not imply Ecology has formally reviewed and approved of the remedial action.

Because of the independent nature of the investigation/cleanup, Ecology's role on this site has been strictly informal. Ecology does not do oversight on independent cleanups, therefore, does not approve or disapprove cleanup actions as referred in WAC 173-340-200 (definition of "independent remedial action"). Independent remedial actions are done at the potentially liable

person's own risk. Please be aware that there are requirements in state law which must be adhered to. Some of these requirements are addressed in WAC 173-340-120(8)(B), and -300(4). Please note Ecology will use the appropriate requirements contained throughout this chapter in its evaluation of the adequacy of any independent remedial actions performed. Regardless of your planned/present actions, Ecology may still need to conduct a more detailed inspection of this property in the future, including testing for possible contamination. At that time, we may assess the need for further action and establish a priority for this work, if needed.

Ecology has a strong commitment to working cooperatively with persons to accomplish prompt and effective cleanups. However, due to limited resources and requirements in state law, we are not always able to provide all the assistance requested. Your cooperation in planning or conducting a remedial action is not an admission of guilt or liability.

If an independent remedial action is undertaken and a formal review of the independent report or consultation during any phase of your independent investigation or cleanup is desired, you may request assistance from Ecology under the Voluntary Cleanup Program (VCP). This program was established in response to the public's need for Ecology to provide formal, detailed guidance to parties conducting independent cleanups, and to more readily review cleanup actions taken.
