

1.0 INTRODUCTION

The Washington State Department of Ecology (Ecology) has developed this Public Participation Plan pursuant to the **Model Toxics Control Act (MTCA)** and a proposed Agreed Order between Ecology and the City of Bothell (Bothell). Ecology is committed to an open dialogue with the community to ensure that interested parties receive information as well as provide input during the decision-making process. The intent is to promote meaningful community involvement during the cleanup process at the Bothell Former Hertz Site (Site). The Site is also known as AA Rentals of Bothell.

SITE LOCATION

The Site is generally located at 18030 Bothell Way NE, Bothell, Washington. It is an approximately rectangular lot bounded by Bothell Way Northeast to the north and Northeast 180th Street to the south (see map on page 4).

The property had been developed from 1918 until 2010, when Bothell demolished buildings on the Site for its SR 522 Bothell Crossroads realignment project. Past property use included automobile repair and dealerships, fueling, and equipment rental. Before the property was purchased by the City of Bothell in 2009, it contained a Hertz equipment rental office, storage yard, and equipment repair shop.

The property contained a building that was used as an automobile dealership. A petroleum company is listed as a lessee of the property in the 1930s. A former building at the northeast corner of the property included a gasoline dispensing facility and Underground Storage Tanks (USTs). Three USTs were removed from the property in 1993, and. Petroleum-affected soils were encountered during removal. An unknown quantity of petroleum contaminated soils remained underneath buildings.

In 2008, the City of Bothell conducted Phase I and Phase II Environmental Site Assessments (ESAs) at the Site prior to its purchase of this and adjoining properties.

The 2008, Phase II ESA included soil and ground water sampling results where three former USTs had been removed. Petroleum hydrocarbons were detected in soil and ground water exceeding state cleanup standards. Vinyl chloride and volatile organic compounds (VOC) were detected at concentrations exceeding state cleanup standards in ground water samples.

Other VOCs were detected in groundwater at the time, including common solvents - tetrachloroethene and trichloroethene. The concentrations were below state cleanup standards. The VOC detections in groundwater appear to be from suspected up-gradient sources. Arsenic was also detected in one well above cleanup levels.

In summer 2010, Bothell completed an independent interim cleanup action at the Site and removed approximately 12,000 tons of petroleum contaminated soils from areas where former underground storage tanks were located. Some limited remedial investigation was also conducted at that time.

2.0 CONTAMINANTS OF CONCERN

The Phase I and II Environmental Site Assessments in 2008 provide the following potential chemicals of concern known at this time. In ground water, they are:

- Petroleum hydrocarbons
- Vinyl chloride
- Volatile organic hydrocarbons (VOCs)
- Arsenic
- Trichloroethene (TCE) detected below state cleanup levels
- Tetrachloreothene (PCE) detected below state cleanup levels

In soil, they are petroleum hydrocarbons in the gasoline and oil range.

3.0 PUBLIC PARTICIPATION ACTIVITIES AND RESPONSIBILITIES

The purpose of this Public Participation Plan is to promote public understanding and participation in the cleanup process for this site. This section addresses how Ecology will keep the public informed about site activity and provide opportunity for being involved in the cleanup.

Ecology will use a variety of tools to facilitate public participation in the planning and cleanup of this site. These tools include: formal comment periods and responsiveness summaries, fact sheets, public meetings (if required), information repositories, Ecology's Site Register, web tools including a web-based events calendar, display advertisement in a local newspaper, and the Bothell Former Hertz (AA Rentals of Bothell) website. These tools will be used as appropriate. Ecology will consider and implement constructive input provided by the community whenever possible.

Ecology and Bothell urge the public to become involved in the cleanup process. Information will be provided regularly in order to provide many opportunities to review materials and provide comments. This plan is intended to be a flexible working document where activities change as community concerns emerge as well as when more information becomes available during the cleanup process. Roles and Responsibilities

Ecology maintains overall responsibility and approval authority for the activities outlined in this plan in accordance with Model Toxics Control Act (MTCA) requirements. Ecology, with the

participation of Bothell, conducts public comment periods as required by MTCA, including soliciting, receiving and considering comments, making decisions, and preparing responsiveness summaries.

Public Comment Periods

Comment periods are the primary method Ecology uses to get feedback from the public on proposed cleanup decisions. Comment periods usually last for 30 days and are required at key points during the investigation and cleanup process before final decisions are made. During a comment period, the public can comment in writing. After formal comment periods, Ecology reviews all comments received and may respond in a document called a Responsiveness Summary. Ecology will consider the need for changes or revisions based on input from the public. If significant changes are made, then a second comment period will be held. If no significant changes are made, then the draft document(s) will be finalized.

Public Meetings

Public meetings may be held at key points during the cleanup process. Ecology may also offer public meetings for actions expected to be of particular interest to the community. Also, if ten or more people request a public meeting during the 30-day comment period, Ecology will hold a public meeting for the purpose of taking written comments on draft documents.

Information Repositories

Information repositories are convenient places where the public can go to read and review Site information. The information repositories are often at libraries or community sites where the public has access. During the comment period, the site documents will be available for review at each repository which is listed below. Documents remain at the repositories for the entire duration of the project.
