## ENVIRONMENTAL CHECKLIST

### *Purpose of checklist:*

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. *The proposal is to excavate contaminated soil from the Site and dispose of the soil in an approved facility. About 245 tons of material will be excavated from the former wash pad area at the Site. An asphalt cap will be placed over other contaminated soil areas. Site restoration will include placing fill soil in compacted lifts to the surface.*


