DETERMINATION OF NONSIGNIFICANCE (DNS)

Proposed Interim Action Work Plan for Upland Area at 8801 East Marginal Way South and former Paccar Kenworth Truck Company Site, Tukwila, Washington

PROJECT DESCRIPTION: The proposed work is to conduct the Interim Action Work Plan for soil and groundwater cleanup at the upland portion of the 8801 East Marginal Way South/former Paccar Kenworth Truck site in Tukwila, Washington. The Interim Action Work Plan is phased with review and approval by Ecology for each task in sequence. The tasks are to complete the remedial investigation (RI), evaluate feasible cleanup alternatives (FS), if necessary prepare a data gaps work plan, then to complete the RI and FS, and then implement the approved Final Interim Action Work Plan at the upland portion of the 8801 Site. The Draft IAWP is currently being reviewed by Ecology at the same time as this public comment period. If public comments and/or Ecology's review require substantial revision to the Draft IAWP or its associated documents, then Ecology will call and conduct another public involvement and comment period.

The proposed Interim Action Work Plan will be conducted under a legal agreement called an Agreed Order (AO) between the potentially liable parties, the former owner, PACCAR Inc (Paccar), and current owner, Merrill Creek Holdings LLC (Merrill Creek) and Ecology. The AO describes the work to be conducted at the upland portion of the site. There is an existing Agreed Order No. DE 3599 between PACCAR Inc and Ecology for sediment evaluation at the site. Site protection after the cleanup work is completed will consist of institutional controls including an environmental covenant (EC) restricting the use of groundwater beneath the site.

PROPONENT: PACCAR INC. and Merrill Creek Holdings, LLC.

LOCATION OF PROPOSAL, INCLUDING STREET ADDRESS: The project is at 8801 East Marginal Way South, in Tukwila, Washington in SW 1/4 Section 33, Township 24N, Range 4E.

LEAD AGENCY: Washington Department of Ecology (Ecology). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public on request. Call Ecology NWRO at 425-649-7190 for review.
