

## **SEPA Determination of Non-Significance Withdrawn and Interim Action Suspended**

In July 2014, the Washington Department of Ecology (Ecology) issued a State Environmental Policy Act (SEPA) Determination of Non-significance (DNS) for an interim (partial cleanup) action at the Crowley Marine Services 8th Avenue South cleanup site. The proposed interim action work included removal of contaminated soil to construct a concrete slab and rail lines. A SEPA public comment period was held July 18 to August 1, 2014. **Based on the comments received, Ecology has withdrawn the DNS.**

During the public comment period Ecology received a letter from the Washington Department of Archaeology and Historic Preservation (DAHP). They identified the project area as having a very high potential for archaeological resources. They are recommending an archaeological survey and additional consultations with concerned parties.

Ecology determined that the SEPA review information provided by the property owner was not complete and withdrew the DNS. The interim action planned for the site has been suspended. DeNovo Seattle LLC, the property owner, is resuming work on the site Remedial Investigation and Feasibility Study.



The site is located on the Lower Duwamish Waterway at 7400 8<sup>th</sup> Avenue South, Seattle and is adjacent to Slip 4.
