## Dear Dr. Tahat:

The Department Ecology (Ecology) thanks you for your interest and mailed comments, dated November 5, 2014, regarding the Moxee POTW Interim Action Plan. The Public Comment Period for this Interim Action Plan ran from November 5 to December 5, 2014, in accordance with the State Environmental Policy Act (SEPA) and Model Toxics Control Act (MTCA). The Yakima Regional Clean Air Agency's (YRCAA's) input was the only set of comments we received. Therefore this letter also serves as Ecology's "Responsiveness Summary" for the Public Comment Period. Below is a summary of the YRCAA's comments and Ecology's response to those comments.

YRCAA Comment #1: Contractors doing demolition, excavation, clearing, construction, or landscaping work must file a Dust Control Plan with YRCAA and get approval, prior to the start of any work. A truck washout or other method of control must be implemented as part of the Dust Control Plan during construction.

YRCAA Comment #2: No soil trail shall be allowed beyond the disturbed soil site.

YRCAA Comment #3: No dust transport shall be allowed beyond the boundary site which may be detrimental to persons or property pursuant to WAC 173-400-040 (6) and (3).

Ecology Response #1-3: No demolition, excavation, clearing, construction or landscaping work is planned. We do not expect this project to generate significant dust or result in erosion or tracking. Therefore, a Dust Control Plan and truck washout are not warranted. Planned ground disturbing activities are minimal with work limited to approximately 22, one-inch diameter, 10-

feet deep lance injections. Very little soil removal is anticipated and all soil cuttings (a.k.a. investigative derived waste (IDW)) will be drummed, profiled and disposed of at a facility permitted to accept such waste. The lance injection locations will be backfilled with bentonite and the asphalt parking area will be patched, restoring the property to its original condition.
