RE: Amendment of Emergency Enforcement Order DE 98TC-C138; Alexander Farms

Dear Mr. Alexander:

On May 7, 1998 Ecology issued you Emergency Enforcement Order No. DE 98TC-C138 for an emergency interim action soil removal, emergency groundwater monitoring, and remedial investigation/feasibility study at the Alexander Farms Facility. Through your efforts and the efforts of the United States Environmental Protection Agency, the emergency interim action soil removal portion of this order has been satisfied. From this date forward, the STATE OF WASHINGTON DEPARTMENT OF ECOLOGY EMERGENCY ENFORCEMENT ORDER NO. DE 98TC-C138 shall be called STATE OF WASHINGTON DEPARTMENT OF ECOLOGY ENFORCEMENT ORDER NO. DE 98TC-C138.

Ecology also hereby amends Section III, paragraph 2 of the Enforcement Order, which currently reads as follows:

2. The facility is known as the **Alexander Farms** facility. The Alexander Farms facility includes all areas where Dinoseb contaminated soil and groundwater at the West King Tull Road site including the residence at 179301 West King Tull Road, the parcel 179101 West King Tull Road, the site located at 4902 North Hicks Road, and any additional properties served by the SVID diversion 49.90, near Grandview, Washington.

As of the date of this letter, Section III, paragraph 2 of the Enforcement Order shall read as follows:

2. The facility is known as the **Alexander Farms** facility. The Alexander Farms facility includes all areas where Dinoseb contaminated soil and groundwater at the West King Tull Road site has come to be located, including but not limited to, Benton County Parcel No. 1-3094-201-2011-001 located at 179301 West King Tull Road, Benton County Parcel No. 1-3094-201-2011-

002 located at 179101 West King Tull Road, and Benton County Parcel No. 1-3194-200-0010-000 located at 4902 North Hicks Road.
