Dear Mr. Oline:

Thank you for working with the Washington State Department of Ecology (Ecology) on the Oline Storage Yard (Site). This letter provides written notification that the remedial actions required by Agreed Order No. DE - 8796 (Order) have been satisfactorily completed and that no further remedial action is necessary to clean up contamination at the Site under the Model Toxics Control Act (MTCA), Chapter 70.105D RCW. This letter also describes the removal of the Site from Ecology's Hazardous Sites List and next steps for dismissing the Decree. The Order became effective on January 3, 2012 and was amended on May 27, 2014.

## Completion of Remedial Action Required by the Order

Ecology has determined the requirements of the Order have been satisfied. Ecology made this determination pursuant to Section IX (Satisfaction of Order).

The remedial actions required by the Order are specified in Section VII (Work to Be Performed) and detailed in the Cleanup Action Plan (Exhibit A to the Order). Don Oline, and subsequently his estate, was required to determine the location of a contaminated tank, submit a waste analysis plan (WAP), implement the WAP, remove and properly dispose of waste materials, provide a RI/FS work plan, implement the work plan, provide a RI/FS report, provide a Draft Cleanup Action Plan (CAP), implement the Final CAP, and provide a Remedial Action Report. After inspecting the Site and reviewing the supporting documentation, Ecology has determined that the remedial actions required by the Order have been satisfactorily completed.

The CAP was implemented by way of an Agreed Order - No. DE - 8796, First Amendment. The estate of Don Oline contacted Ecology to enter negotiations for the Agreed Order Amendment and Ecology accepted the request. The Order and CAP went out for public comment between April 21, 2014 and May 21, 2014. The CAP was subsequently implemented and a Remedial Action Report – PCB Remedial Action Report, Estate of Don Oline Storage Yard, 1915 Marine View Drive, Tacoma, Washington, Environmental Partners, Inc., September 25, 2014 published and provided to Ecology. The report was reviewed and approved by Ecology September 29, 2014.

### No Further Action Determination

Ecology has determined that no further remedial action is necessary to clean up contamination at the Site under MTCA. Ecology has also determined that no post-cleanup controls or monitoring are necessary under MTCA.

## **Delisting of the Site**

Based on the no further action determination, Ecology has proposed removing the Site from the Hazardous Sites List (HSL). Ecology will publish notice in the Site Register on February 5, 2015. During the 30-day public comment period, comments will be received. After review and consideration of the comments, Ecology will remove the Site from the HSL on or about March 9, 2015.
