Thank you for submitting the results of your independent remedial action(s) for review by the State of Washington Department of Ecology (Ecology). Ecology appreciates your initiative in pursuing this administrative option under the Model Toxics Control Act (MTCA).

Ecology's Toxics Cleanup Program has reviewed the following information regarding Bill's Gas & Country Store (formerly Bill's Cut Rate Gas Station), 817 E Woodin Ave., Chelan, WA, Facility Site #55999815 (VCP #CE0185):

- Restrictive Covenant dated November 25, 2003
- > Water Well Report #W155185 by MVM Quality Drilling, LLC, dated May 29, 2002
- UST-Site Investigation and Final Cleanup Report for Bill's Cut Rate Gas Station, Chelan, WA, by NetCompliance Products & Services, Inc., dated January 2000
- Site Assessment and Decommissioning for Bill's Cut Rate Gas Station, Chelan, WA, by Blue Ridge Associates, Inc., dated August 10, 1992

Based upon the above listed information Ecology has determined that, at this time, the release no longer poses a threat to human health or the environment. Therefore, Ecology is issuing this determination that no further remedial action is necessary at this site under MTCA, chapter 70.105D RCW. However, please note that because your actions were not conducted under a consent decree with Ecology, this letter is written pursuant to RCW 70.105D.030(1)(i) and does not constitute a settlement by the state under RCW 70.105D.040(4) and is not binding on Ecology.
