#### **Background Information**

In 2014, the Washington State Department of Ecology (Ecology) and Skagit County entered into a legal agreement on January 14, 2015 called a Prospective Purchaser Consent Decree (PPCD). Under this PPCD, Ecology and Skagit County agreed to clean up the Truck City Truck Stop site located at 3216 Old Highway 99 South in Mount Vernon, Washington.

To prepare for and guide the cleanup, Skagit County conducted a Remedial Investigation/Feasibility Study (RI/FS), and prepared a Draft Cleanup Action Plan (CAP) which was finalized by Ecology following public notice and comment. The RI identified the nature and extent of contamination at the site; the FS assessed alternative ways of cleaning up the contamination and the CAP detailed the selected cleanup action.

The Site was developed in 1952 as a fueling facility for Standard Oil and operated as an independent entity since 1976. A convenience store, restaurant, and truck wash were constructed in 1978.

Fifteen former fuel-containing underground storage tanks (USTs) have been identified. Two historical tanks and one septic tank containing waste oil (removed in 1993) were located east of the current truck scale. The current and only operational UST area, located east of the convenience store, houses three 5,000-gallon gasoline USTs and one 15, 000-gallon diesel UST.

The Draft Public Participation Plan (PPP) outlined and described the tools and approaches that Ecology plans to use to inform the public about site activities. It also identifies opportunities for the community to become involved in the site cleanup process.

A public comment period was held December 1 through 31, 2014. Ecology requested public comments on the PPCD, Draft RI/FS, Draft CAP, and Draft PPP.

A public meeting/public hearing was held on December 11, 2014 at the Skagit County Administration Building from 5:30 - 8:00 p.m. The meeting was an opportunity for the citizens to learn more about the planned cleanup activities, to ask questions, and to provide Ecology with their comments.

Ecology received four written or emailed comments and one public hearing comment during the comment period. This Responsiveness Summary provides Ecology's response to these comments.

Mr. Rosenfeld stated that he was against the location of the new Jail and that it was his opinion that since the Truck Stop had been there since the 1950's that it was better to leave the Truck Stop and the contamination which could not be cleaned up there and to select a different location for the Jail. Ecology told Mr. Rosenfeld that the Truck City Site was a high priority cleanup in the public interest. Ecology referred Mr. Rosenfeld to Mr. Marc Estvold (working for Skagit County) for questions pertaining to the County's selection for the new Jail facility.

#### DOUGLAS PALENSHUS

Department of Ecology, PUBLIC COMMENT SPEAKERS: TIM HOLLORAN (Beginning of public hearing portion.) MR. PALENSHUS: So I'm DouGlas Palenshus I'm with Ecology and I'm the hearings officer for tonight's public hearing. And I, had anyone determined that they would like to make public comments for the record tonight? You would. So it's not time for that, sir --

MR. HOLLORAN: Okay.

MR. PALENSHUS: -- quite yet. And we'd publicized the hearing beginning at 7:00 so for that reason I do not want to start the hearing until 7:00. At that time we can hear from anyone who would like to make public comments for the record, we'll open that opportunity up, we'll be recording it with a court report and --

AUDIENCE MEMBER: Would your e-mails and stuff count too if you wrote a letter? That's still part of the public record? MR. PALENSHUS: Yes.

AUDIENCE MEMBER: So I'm good.

MR. PALENSHUS: So, sir, we're going to wait until 7:00 for the public hearing part. In the meantime if there are further questions or if you'd like to step out and look at those displays that have been prepared outside, feel free, eat snacks, go to the restroom. At 7:00 I will open the public hearing to anyone who wishes to makes comments and I'd invite everyone back in here if you'd like to do that, otherwise enjoy the soft chairs.

(Break from the hearing.)

MR. PALENSHUS: If there is anyone in the foyer that we'd like to invite back in to take a seat, Missy perhaps, is there anyone in the foyer we'd like to invite back in?

So I'm DouGlas Palenshus, I'm the hearings officer. So let the record show that the hearing has started at 7:03 p.m. on December 11, 2014 at the Skagit County Office at 1800 Continental Place, Mount Vernon, Washington 98273.

So tonight's hearing is on the cleanup action plan for Truck City Truck Stop and I really do appreciate everybody coming out and being part of the meeting tonight. So notice of hearing was published in the Skagit Herald on November 28th and December 13, 2014. Notices of public hearing and meeting were also mailed to 4045 residents of the local area and posted in the public involvement calendar on the Department of Ecology's public website. A dedicated web page is available at the address in the fact sheet at the sign-in table. That's out, and I really urge you to get a copy of, I looked it over and not being very familiar with the project myself, I thought that the information in the fact sheet was quite good so I urge you to take a look at that.

So I have two main responsibilities for tonight's hearing; first I need to make sure everyone who wants to has the opportunity to come up and comment, second so that everyone can hear what is said and you get a clear record of the hearing. We have a court reporter and microphones and audio recording equipment so no extra noise, please. Staff may also take notes. I'll call those who signed up, I think it's only one person. Anyone else that's decided they would like to make a public comment for the record?

So if you -- I'll skip through some of this. Commenters will come to the podium right here, that will be here, where we can record them so we can all hear. Written comments have the same weight so you can just send them to Dale Myers if you wish, all comments are sent to the cleanup program staff for response.

Questions asked as part of your testimony will not be answered during the formal hearing. Testimony is a formal verbal submission and not an opportunity for dialogue and we can not enter into any discussion. So anyone making formal comments may include questions for the record then just continue with comments and we'll, staff will be around afterwards if you wish to have further questions or discussion.

Final -- we can skip that. And we can skip much of this because we only have one person identified to speak.

So I'd like to invite Tim Holloran, if you would, please, state your name and your affiliation? Thank you.

MR. HOLLORAN: Sure.

MR. PALENSHUS: Thanks, Tim.

MR. HOLLORAN: It's very unusual to have one speaker. My name is Tim Holloran, I'm the Skagit

County Administrator, I'm here on behalf of the

county commissioners. And it's more of a, I want to acknowledge all the hard work on this project. First off this is an essential public facility, building a jail is big time for, not only for a city but for a county. It's, we'd be a county-owned facility, but it's a partnership with all our cities.

Mark's done a great job as a project manager, but in particular I want to thank Ecology for their quick response and their professionalism in dropping everything to make that happen. Ecology and Skagit County hasn't always gotten along on issues, but we're big enough to separate issues and really the professionalism is there. So it's important for me to thank Ecology for the professional work, the quick response, recognizing that this site had a partial cleanup or had a cleanup and when we found, the county commissioner said we better do our due diligence, this was a Truck City site. And the commissioners were concerned about not only contaminants on the site, but if you hear horror stories a lot of times contaminants go across roads into other sites.

The other group, Jim Darling and his staff from Maul Foster Alongi, we couldn't do it without them. They have got the experience, they have worked in many, with Ecology on many, many projects. Their professionalism has brought us along the way.

This is a great project from the Model Toxics Fund. It's intended to clean up contaminated areas. We're fortunate that this has had a previous cleanup, there is not a lot of cleanup, but it's significant enough to do it right. So my comment is to thank Ecology first and foremost. Thank you.

MR. PALENSHUS: Thank you, Tim. One last time, anyone wishing to make public comments for the record? Seeing none.

All right. So I just want to say before I continue this material that I must read into the public record that basically feel free to -- this is a formality; all testimony received at this hearing along with all written comments that are received are postmarked by 5:00 p.m. December 31, 2014, will be part of the official hearing record for the Truck City Truck Stop Cleanup Action Plan. After considering the comments received and evaluating the plan for consistency with relevant regulations, policies and guidelines, Ecology may approve the cleanup plan for Truck City Truck Stop as is or require changes to improve the cleanup plan. Comments received will help Ecology make a decision and the questions, comments and responses will be published in a responsiveness summary.
