Dear Dr. El-Moslimany:

ECC Horizon has tested soil and groundwater within the above referenced property as described in our 1/21/10 and 10/30/13 access agreements with the Islamic School of Seattle (ISS). We used the resulting information to help characterize chlorinated solvent impacts at the adjoining *Cherry Street Cleaners* site, which is located at 2510 East Cherry Street. This property on East Cherry Street is owned by Vera Benton, who is responsible for remediating the impacts.

To remediate subsurface conditions in this matter, contaminated soils must be excavated from the *Cherry Street Cleaners* property. To access those soils, however, the excavation could extend up to 15 feet into the ISS property. Consequently, we request permission to remove and replace soils in the southern portion of the ISS property, if needed.

The planned remedial activities may be conducted for up to 6 weeks. Any areas of the ISS property that are disturbed as a result of these activities will be restored. Please be assured that we will cooperate with ISS in this regard.

To begin our work, we ask that you and/or the appropriate official(s) sign your name(s) in the places provided on the following page. You may then return the signed original document to us in the enclosed, self-addressed stamped envelope. If you prefer, you may send a fax copy of the executed agreement to us as well.
