**Re: Determination of Potentially Liable Person Status**

Dear Mr. Thompson:

On December 23, 2014 the Department of Ecology (Ecology) sent you written notice regarding your proposed status as a potentially liable person (PLP) for a release of hazardous substances at the following site:

The 30-day comment period, including a 30-day extension, on this preliminary notice expired on February 28, 2015.

We have received and carefully evaluated your comments in a letter prepared on your behalf by Laura Maffei (Cable Huston LLP), dated February 26, 2015. Based on the information available to date, Ecology finds that credible evidence exists which supports your status as a potentially liable person for the release at the USG Interiors Inc Hwy 99 Site (Site). On the basis of this finding, Ecology has determined that you are a Potentially Liable Person (PLP) with regard to the Site.

In regard to your comments, Ecology has determined that credible evidence exists that arsenic contamination resides on your property in excess of Model Toxics Control Act (MTCA) cleanup levels (WAC 173-340-900, Table 720-1). MTCA is clear that your property is considered a



“facility”, meaning a location where a hazardous substance has been disposed of or otherwise came to be located, and that you are the owner or operator. Cleanup of the contamination, or an administrative action (i.e. environmental covenant), must occur in order to protect human health and the environment.

Your rights and responsibilities as a PLP are outlined in Chapter 70.105D RCW, and WAC 173-340. Ecology's site manager for the facility, Jason Landskron, will contact you with information about how Ecology intends to proceed with the cleanup at this site.
