The 30-day comment period on this preliminary notice expired on October 6, 2014. We have received and evaluated your comments found in your October 3, 2014 letter. Based on the information available to date, Ecology finds that credible evidence exists which supports the Boeing Company's status as a potentially liable person for the release at the Boeing Kent Space Center Site. On the basis of this finding, Ecology has determined that the Boeing Company is a Potentially Liable Person (PLP) with regard to Boeing Kent Space Center Site.
