

Proposed Removal from the Hazardous Sites List

The Washington Department of Ecology (Ecology) proposes taking Oline Storage Yard off the Hazardous Sites List. You may comment on this decision from **February 6 - March 9, 2015**. The box to the right shows how to submit comments and where you can find:

- The draft letter to the Oline Estate approving cleanup.
- The Remedial Action Report, which describes how Oline cleaned up the site and why Ecology believes cleanup is complete.

Background

The Oline site is located at 1915 Marine View Drive in Tacoma (see map on back). Don Oline used the site as a salvage yard. This resulted in waste chemicals and petroleum products building up at the site.

Between 2002 and 2008, the Tacoma-Pierce County Health Department, Ecology, and the Environmental Protection Agency (EPA) inspected the site and found contaminants.

The main contaminant of concern is polychlorinated biphenyls (PCBs). High levels of PCBs were found in waste oil and in soil. PCBs were used as coolants and lubricants before 1977, but can remain in the environment for a long time.

Site Cleanup

In 2012, Don Oline entered into an agreed order (agreement) that required him to remove the hazardous waste.

In 2014, 16.5 cubic yards of PCB-contaminated concrete and soil was removed from the site and disposed of at a landfill.

Cleanup is complete. Test results show that the cleanup was successful.

What Happens Next

After the comment period, we will respond to comments. We will send responses to those who commented and post it to our website. The last step is to remove the site from the Hazardous Sites List.

What is the Hazardous Sites List?

The Hazardous Sites List includes sites that Ecology has assessed for their potential risk to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.

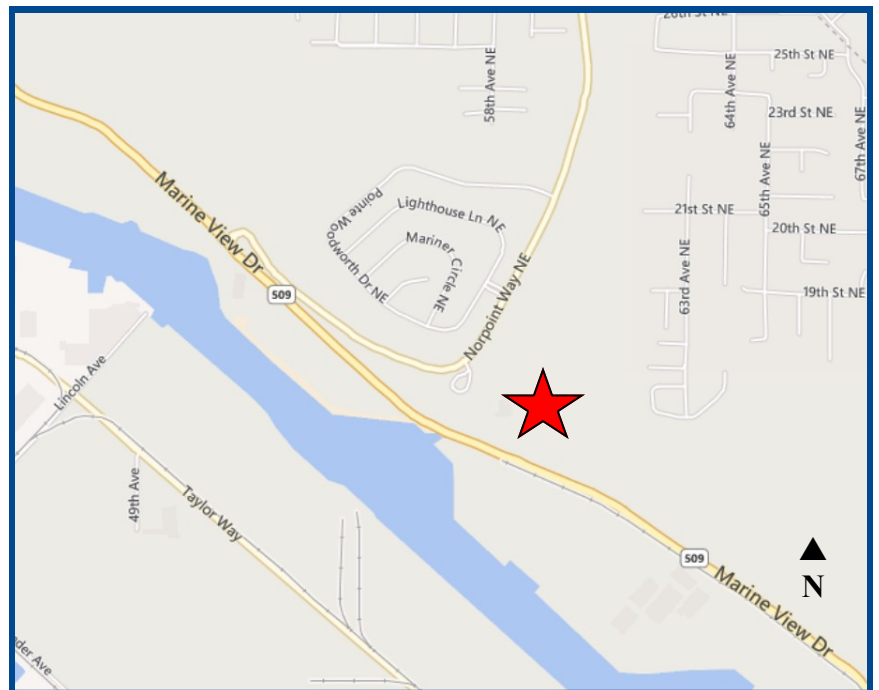
