Dear Mr. Beck:

The week of May 24, 2010, the Washington State Department of Ecology (Ecology) received two signed copies of Agreed Order #7347 from PSC Environmental Services (PSC). Thank you for signing the order and returning both copies. Ecology has also signed the order and one copy with both original signatures is enclosed (Enclosure A). The effective date of the PSC-Georgetown order is May 28, 2010.

Ecology has also made a final permit decision pursuant to WAC 173-303-840(8) for the Burlington Environmental, LLC (PSC) facility. The final permit is enclosed (Enclosure B) and today's letter serves as notice of our decision. Today's mailing date corresponds to the permit's *issuance* date. Therefore, the permit will become effective "thirty days after the service of notice of the decision," unless a review or evidentiary hearing is requested (as described in WAC 173-303-840(8)(b)(iii)). Once effective, the new final permit replaces the current (expired) facility permit. No changes were made to the draft permit provided to the public for comment; the final permit therefore contains the same language that was in the draft document.

A public comment period was held from February 10 through March 26, 2010, to solicit comment on PSC's draft Dangerous Waste Management permit and draft MTCA Agreed Order for the Georgetown facility and site. Responses to the comments Ecology received during the comment period are enclosed (Enclosure C). The responses to comments and notification concerning the Department's final permit decision have also been sent to those individuals who provided comments during the comment period, and any individual who requested this information.
