

Proposed Removal from the Hazardous Sites List

The Department of Ecology (Ecology) proposes taking the BP Station 03158 site off the Hazardous Sites List. It is located at 501 Trosper Rd. in Tumwater. We are accepting comments on this decision from **June 29 - July 30, 2015**. The box to the right shows where to find:

- A No Further Action letter that describes and approves the cleanup.
- Background information about the site.

Site Background and Cleanup

This site is a former gas station. Most recently it was operated by Fred Meyer. From 1991 - 1995, investigations found soil and groundwater polluted with gasoline, diesel, and heavy oil petroleum hydrocarbons, and related volatile organic compounds.

From 1995 - 1998, the owners removed contaminated soil and underground storage tanks. A soil vapor extraction system removed 1,091 pounds of contamination. In 2012, the gas station closed and owners removed the rest of the tanks and pumps. After cleanup, sampling found only remaining groundwater contamination. The owners injected a compound to help break down the remaining pollution.

The past four quarters of sampling show no contamination above cleanup levels. Ecology considers cleanup complete. The site was cleaned up under the Voluntary Cleanup Program.

What Happens Next

1. Through July 30, Ecology invites you to comment on our decision to remove the site from the Hazardous Sites List.
2. After the comment period, we will respond to comments.
3. We may require further sampling or cleanup based on information given by the public. Otherwise, we will remove the site from the Hazardous Sites List.

What is the Hazardous Sites List?

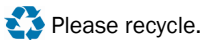

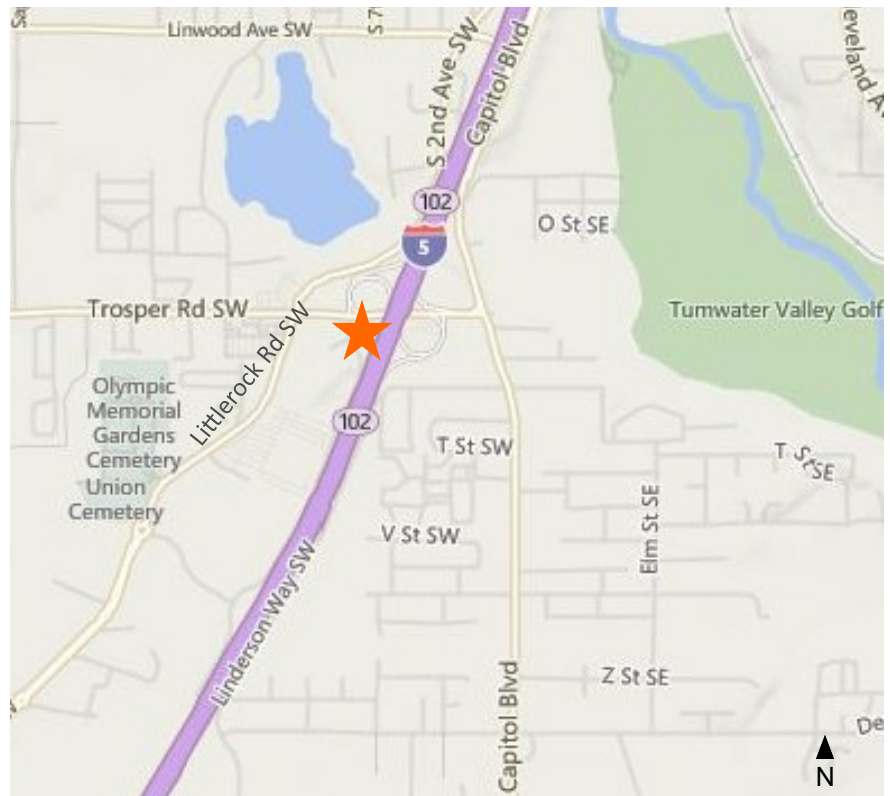
