#### Dear Mr. Pontius:

The Department of Ecology (Ecology) is terminating the VCP Agreement governing Project No. NW1610. The project involved the cleanup of the SHORT STOP 1 facility. The effective date of termination is the date of this letter. We are providing this notice in accordance with the terms of the Agreement.

#### Reason

Ecology is terminating the Agreement because of your e-mail dated July 21, 2015 (enclosed) to Ecology's VCP Financial Manager that you were effectively withdrawing from the VCP Contract Agreement binding VCP Services between Ecology and the SHORT STOP 1 facility.

#### **Next Steps**

Based on this decision, Ecology may take one or more of the following steps:


- 1. Send you an invoice for any costs remaining on your account. In accordance with the terms of the Agreement, you remain responsible for any costs incurred by us before the effective date of termination.
- 2. Conduct a site hazard assessment (SHA) and rank the Site for further action.
- 3. Identify those persons we find potentially liable for cleanup of the Site.
- 4. Initiate discussions for an agreed order or consent decree that will govern further action at the Site.


