RE: Determination of Potentially Liable Person Status

Dear Mr. Osborne:

On December 13, 1991 the Department sent you written notice regarding your proposed status as a potentially liable person for a release of hazardous substances at ~~Town Pump~~; 521 East Jewett Boulevard, ~~White Salmon, WA.~~ The 30 day comment period on this preliminary notice expired on January 16, 1992.

We have received no comments from you as of January 16, 1992. Based on the information available to date, the Department finds that credible evidence exists which supports your status as a potentially liable person for the release at Town Pump, White Salmon, WA. On the basis of this finding, the Department of Ecology has determined that you are a Potentially Liable Person (PLP) with regard to Town Pump, White Salmon, WA.

Potentially liable persons are encouraged to initiate discussions with Ecology and the Attorney General's office which will lead to remedial action at their site. Potentially liable persons may initiate a remedial action by submitting a letter to Ecology requesting either an Agreed Order or a Consent Decree. Ecology may initiate a remedial action by either inviting negotiations on a Consent Decree or by issuing an unilateral Enforcement Order.

As of the date of this letter, Ecology has also determined that the following persons are found to be a PLP with regard to the above-referenced site:



Your rights and responsibilities as a PLP are outlined in Chapter 70.105D RCW, and WAC 173-340. Ecology's site manager for the facility, Mike Cochran, will contact you with information about how the Department intends to proceed with the cleanup at this site.
