

Agreed Order Available for Public Comment

The Washington State Department of Ecology (Ecology) invites you to comment on the proposed agreed order for the Gig Harbor Sportsman's Club cleanup site. This site is located at 9721 Burnham Drive NW in Gig Harbor.

Ecology Wants Your Comments!

Ecology will accept comments from **September 17– October 19, 2015** on the proposed agreed order. The agreed order is a legal agreement that requires the Gig Harbor Sportsman's Club to:

- Conduct a remedial investigation (RI), which will describe the nature and extent of the contamination on the site.
- Conduct a feasibility study (FS), which will evaluate cleanup options.
- Submit a draft cleanup action plan, which will outline proposed cleanup actions for the site.

The Public Participation Plan is also available for review. It describes the tools Ecology will use to inform the public and gather feedback.

The box to the right shows where you can review documents and how to submit comments.

Site Background

The Gig Harbor Sportsman's Club has operated on the 35 acre property since the 1940s. The site currently has a shotgun range and a 100-yard combination rifle and pistol range.

The Tacoma-Pierce County Health Department (TPCHD) conducted an initial investigation in 2002. They found surface water samples from an intermittent tributary of North Creek with lead above the state cleanup level. Ecology sampled in 2008 and found similar results. This tributary flows across the Sportsman's Club property.

What Happens Next

After the comment period, we will respond to comments. We will then finalize the agreed order.

You will be invited to review and comment on the investigation and cleanup documents as the cleanup moves forward.

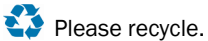

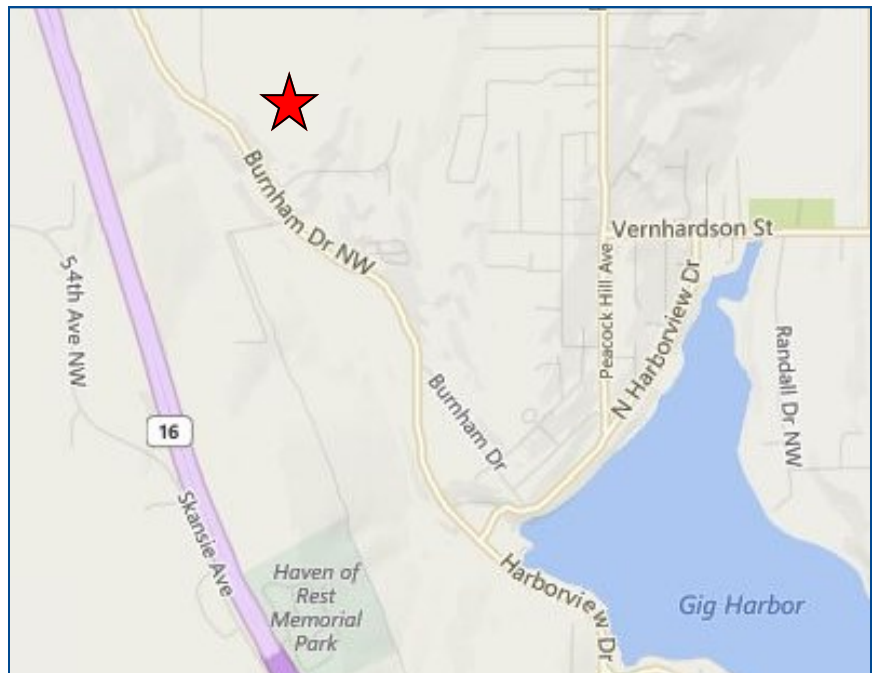
