FIRST AMENDMENT TO CONSENT  
DECREE

The Consent Decree of January 2, 2004 (“Consent Decree”) is hereby amended, by stipulation of all parties pursuant to Section XV of the Consent Decree, to require the Defendants to monitor groundwater in accordance with the *Hidden Valley Landfill Groundwater Monitoring Plan*, SCS Engineers (August 8, 2014), which is attached hereto as Exhibit F.


This amendment supersedes the requirement for the Defendants to monitor groundwater in accordance with the final Groundwater Compliance Monitoring Plan dated February 2001, as stated at page 1, lines 13-14 of the Consent Decree; at Page 9 of Exhibit B to the Consent Decree; and under Task 1 of Exhibit C to the Consent Decree. The reference at page 8, line 5 of the Consent Decree to the Groundwater Compliance Monitoring Plan is replaced by a reference to the *Hidden Valley Landfill Groundwater Monitoring Plan*, SCS

1 Engineers (August 8, 2014). All other provisions of the Consent Decree, including its




