Pursuant to Section XVI of the Consent Order on the Greenacres Landfill, Spokane County, Washington, executed October 2, 1987, the State of Washington, Department of Ecology and the County of Spokane hereby amend said Consent Order as follows:

Section XII, paragraphs A and B, of the Consent Order (on page 16) are amended to read as follows:

- A. Spokane County agrees to reimburse the State Toxics Control Account of the State of Washington for reasonable and appropriate costs associated with Ecology activities at the Site conducted during the implementation of this Order. Within ninety (90) days of the end of each fiscal quarter, Ecology will

submit to Spokane County an itemized statement of Ecology's expenses for the previous quarter. Following receipt of the itemized statement, Spokane County shall pay, within ninety (90) days, into the State Toxics Control Account of the State of Washington, the required sum which shall not exceed a total of 12 percent of Spokane County's contractual costs incurred in relation to fulfill this Order.

B. Spokane County agrees to reimburse the State Toxics Control Account of the State of Washington for all reasonable and appropriate costs associated with Ecology's response activities at the Site conducted prior to the implementation of this Order. Ecology will submit to Spokane County an itemized statement of Ecology's expenses incurred prior to the implementation of this Order. Within 90 days after receipt of Ecology's itemized statement Spokane County shall pay, into the State Toxics Control Account of the State of Washington, the required sum.

All other provisions of Consent Order No. DE 87-0926 remain the same. The sole intent of this Amendment is to provide a mechanism to channel expenses recovered pursuant to Section XII of Consent Order No. DE 87-0926 into the State Toxics Control Account.
