

Proposed Removal from the Hazardous Sites List

The Department of Ecology (Ecology) proposes taking the Unocal Bulk Plant 0885 site off the Hazardous Sites List. You are invited to submit comments on this decision from December 24 - January 22. The box to the right shows where to find:

- A No Further Action letter that describes and approves the cleanup.
- Background information about the site.

Site Background and Cleanup

From 1926 through 1992, gasoline was stored and distributed on this site. It is located at 333 6th Avenue in Woodland. During that time, soil and groundwater were contaminated with petroleum hydrocarbons and related volatile organic compounds. In 1992, all of the fuel storage tanks and associated structures on the site were removed.

Unocal owned the site until 2005. Chevron merged with Unocal in 2005 and currently owns the site.

In 2001 and 2012, the owners removed over 1,900 cubic yards of contaminated soil and replaced it with clean soil. In 2005, the owners removed and treated contaminated groundwater using a system of carbon filters.

Groundwater tests show all contamination is below cleanup levels. Ecology considers cleanup complete. The site was cleaned up under the Voluntary Cleanup Program.

What Happens Next

1. Through January 22nd, Ecology invites you to comment on our decision to remove the site from the Hazardous Sites List.
2. After the comment period, we will respond to comments.
3. We may require further sampling or cleanup based on information given by the public. Otherwise, we will remove the site from the Hazardous Sites List.



What is the Hazardous Sites List?

The Hazardous Sites List includes sites that Ecology has assessed for their potential threat to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.

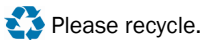

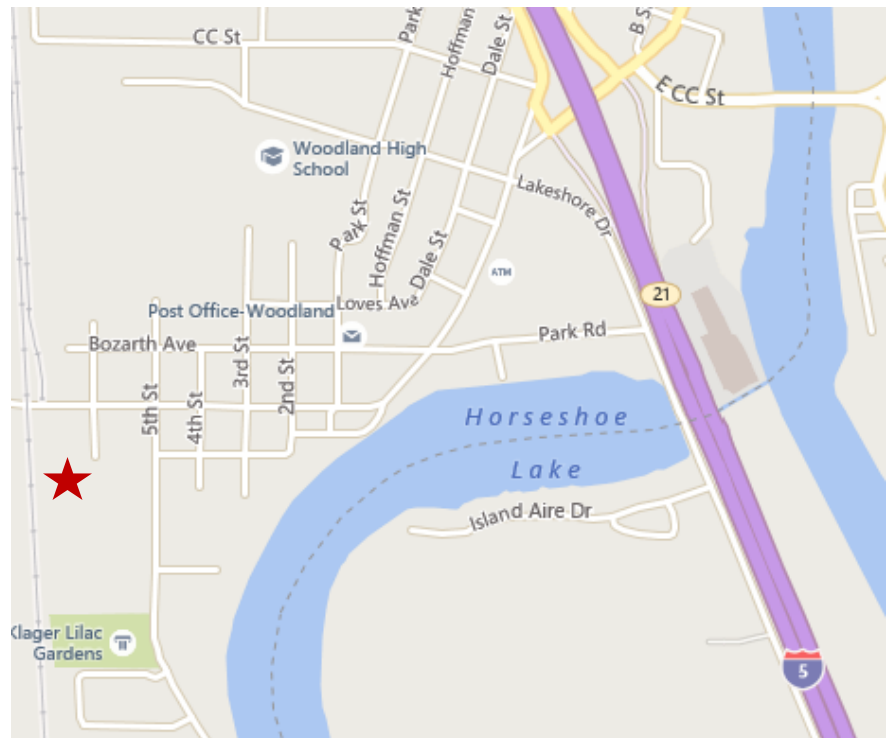
