Agreed Order Available for Review and Comment

The Washington State Department of Ecology (Ecology) is providing an opportunity for the public to comment on the Agreed Order for Remedial Investigation and Feasibility Study for the Smith KEM Site located at 200 South Railroad Avenue in Ellensburg.

Site Background

The current Smith KEM site was operated as a bulk fuel facility by Shell Oil Company from approximately 1923 until the early 1970s. From 1948 until February 2, 1973, Shell leased a portion of the site to Smith KEM, an agrichemical business.. The chemicals offered by Smith KEM included anhydrous ammonia, fertilizers, petroleum, and pesticides. These chemicals were handled, stored and distributed by Smith KEM.

Site investigations began in 2007 and continue currently. Sampling shows groundwater contaminated with petroleum hydrocarbons, nitrates, ammonia, chlorinated pesticides and herbicides. In 2015, Ecology began negotiations for investigation and cleanup with Shell Oil Company and Smith KEM. Ecology considers both companies to be "potentially liable persons (PLPs)." PLPs are responsible for cleanup under Washington State law. The investigation and cleanup are outlined in the Agreed Order.

Toxics Cleanup Program

An Agreed Order is an agreement between Ecology and the PLPs about what work should take place. Ecology is requiring the PLPs to complete a remedial investigation and feasibility study. A remedial investigation provides information about what contamination is present, and how far it extends. A feasibility study will compare different ways to clean up the site. It includes information about how much the cleanup will cost as well as how long it will take. After Ecology reviews this information, a decision about how to move forward with cleanup will be made.

Why This Investigation Matters

The contamination present at the Site includes petroleum hydrocarbons, herbicides and pesticides. Petroleum hydrocarbons contain many chemicals that are harmful to human health and the environment, like benzene, a known carcinogen. Herbicides and pesticides are pollutants that accumulate in the food chain and persist in human and animal tissue. Ecology wants to address risks to human health and the environment.

What Happens Next?

After the public comment period ends, Ecology will review comments received during the comment period and respond. We will make changes to the Agreed Order if needed based on public comments.
