Soil Cleanup at Fort Nisqually Park


The Washington Department of Ecology is cleaning up soil contamination at Fort Nisqually Living History Museum in Tacoma. This is part of Ecology's ongoing work to clean up arsenic and lead. These toxic metals were carried by the wind from the former Asarco copper smelter and contaminated soil over a large area of Puget Sound.

The **Soil Safety Program** provides free soil sampling and cleanup for play areas at schools, childcares, parks, and camps. Funding for this work comes from a \$94.6 million settlement from Asarco.

Soil cleanup will start in January 2016

Surface soil at Fort Nisqually is over the state cleanup level for arsenic and lead. We plan to remove soil from inside the Fort and nearby meadow area (see map on back). We will replace the contaminated soil with clean soil and plant grass seed. Also, we will add mulch to the picnic area near the parking lot.

The Fort and picnic area will reopen in March 2016, but please stay on the new pathway to allow the grass to grow. The meadow cleanup area will re-open once the grass is fully grown.

What are the health risks?

Contamination levels at Fort Nisqually do <u>not</u> pose an immediate health threat. However, long-term exposure to arsenic can contribute to heart disease, diabetes, and certain cancers. Lead is especially harmful for young children. It can damage developing nervous systems and contribute to behavioral problems. Take **healthy actions** (see front) to lower your exposure.
