Per your environmental consultant's (Sound Earth Strategies) email (12/18/14) and written request dated December 17, 2014, The Washington State Department of Ecology (Ecology) approves a second time extension to dispose of the remaining 11,000 tons of listed waste contaminated soils referenced in the Ecology March 26, 2014 letter (attached). You or your consultants shall complete the disposal of the 11,000 tons of listed waste contaminated soils by January 31, 2015 in accordance with ALL other requirements in the previous Ecology letter dated March 26, 2014. The remaining onsite listed waste contaminated soils must be managed as dangerous wastes after January 31, 2015. All other terms and conditions for disposal of the listed dangerous waste soils in the previous Ecology letter dated March 26, 2014 still remain in effect. Please note the importance of the specific requirement on page 2 of the Ecology letter dated March 26, 2014:

- I. Send copies of all signed solid waste landfill receipt records for these contaminated soils to Ecology, attention of Dean Yasuda, within 15 days of your receipt. Also indicate the total volume/weight of all contaminated soils disposed of under the Ecology approved contained-in determination, and indicate if this total amount is above, below or equal to the total amount approved by this Ecology letter. This is an important verification step for you and your environmental consultant to follow in order for this Ecology decision to be valid.

Shawn and Pete,

If you submit a request for a time extension please include the following information at a minimum:

1. Approximate amount of contaminated soils already excavated and disposed under the Ecology approval letter, dated March 26, 2014.
2. Approximate amount of contaminated soils yet to be excavated and disposed under the Ecology approval letter. Note that (1) + (2) must be equal to or below the Ecology written approved amount;
3. Indicate using the figures attached in the Ecology approval letter, where those yet to be excavated contaminated soils are located.
4. Amount of additional time to complete (2) above.

I am planning to be in the office mostly M-Th throughout much of December 2014, but on vacation from Dec 30<sup>th</sup> (Tu) through Jan 5<sup>th</sup> (M) AM. Back on Jan 5<sup>th</sup> PM.

For now, please respond with your best answer to (1) so Ecology has an understanding at this time of how far behind schedule the work might be. If the details of the time extension are straight forward, I think I can review and respond to a time extension proposal < 1 week.
