On behalf of the Port of Seattle (Port), this Monthly Progress Report provides a summary of all activities conducted during the month of February 2016 for the Lora Lake Apartments Site (Site) in Burien, Washington. Work is being performed pursuant to the requirements of the September 9, 2015, Consent Decree No. 15-2-21413-6 (CD) between the Port and the Washington State Department of Ecology (WSDOE). This report is organized to include all requirements listed in Section XI of the CD.

ON-SITE ACTIVITIES THAT HAVE TAKEN PLACE DURING THE MONTH—SECTION XI(A)

- Submittal of the Monthly Progress Report documenting activities conducted during the month of January 2016 on February 16, 2016.
- Follow-on pre-excavation compliance monitoring soil sampling at the Lora Lake Apartments Parcel to finalize the extent of soil excavation to be conducted at the Site on February 1, 2016.
- Preparation for and attendance at a meeting with WSDOE on February 8, 2016, to review results of compliance monitoring conducted to date at the Site.
- Geologic and chemical sample collection at the Lora Lake Apartments Parcel to inform excavation extent and geotechnical design components of the remedial design on February 23 and 24, 2016.
- Ongoing data analysis and development of the Draft Compliance Monitoring Data Report.
- Ongoing preparation of the Draft Engineering Design Report for the Site.
- Ongoing preparation of the 60 percent design drawings and specifications for the Site.

This delay in EIM data submittal does not impact the overall project schedule.
